### CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment is by and between Associated Foreign Exchange, Inc., ("AFEX") a California corporation with an address of 21045 Califa Street, Woodland Hills, California 91367, Fleetcor Technologies, Inc. ("Fleetcor"), a Delaware corporation having an address of 3820 Peachtree Road, Suite 2400, Atlanta, Georgia 30305 USA, and Cambridge Mercantile Corp. (U.S.A.) ("CMC USA"), a Delaware corporation having an address of 1350 Broadway, Suite 810 New York, NY 10018.

- A. Whereas, the business of AFEX, including its trademarks (and the trademark registrations identified in Exhibit A) ("the Trademarks") and associated goodwill, was purchased by Fleetcor on June 1, 2021;
- B. Whereas, as a result of various subsequent intercompany reorganization agreements the Trademarks are now owned by a legal affiliate of AFEX and Fleetcor, CMC USA; and
- C. Whereas the various intercompany reorganization agreements did not specifically list the trademarks and associated goodwill, so the parties hereby confirm same. Now therefore:
  - 1. AFEX hereby confirms that, effective as of June 1, 2021, it assigned, and it hereby assigns, to Fleetcor, the Trademarks, together with the goodwill of the business associated with and symbolized by the Trademarks.
  - 2. Fleetcor hereby confirms that effective as of September 14, 2021, it assigned, and it hereby assigns, to CMC USA, the Trademarks, together with the goodwill of the business associated with and symbolized by the Trademarks.
