Pursuant to the provisions of Sections of 10.154 and 10.155 of the Texas Business Organizations Code (the "TBOC"), the undersigned converting entity certifies the following Certificate of Conversion adopted for the purpose of effecting a conversion in accordance with the provisions of the TBOC.

FIRST: The name of the converting entity will be Circa Lighting, Inc. (the "Converting Entity"). The Converting Entity is a Georgia corporation organized pursuant to the laws of the State of Georgia. The Converting Entity's date of formation was July 13, 1998.

An executed Plan of Conversion will be on file, from and after the conversion, at such address.

FIFTH: A copy of the Plan of Conversion will be furnished by the Converting Entity, prior to the conversion, or the Converted Entity, from and after the conversion, on written request and without cost, to any shareholder of the Converting Entity or any member of the Converted Entity.

SIXTH: In lieu of providing the tax certificate, the Converted Entity is liable for the payment of any franchise taxes.

SEVENTH: This document becomes effective when it is accepted and filed by the Secretary of State of Texas.

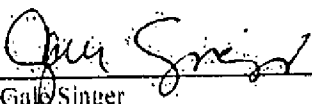

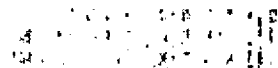


