THIS **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** dated as of 12/13/22 (“Release”) is made by **BANKERS TRUST COMPANY**, an Iowa state-chartered bank (“Lender”), under that certain Intellectual Property Security Agreement dated as of May 21, 2020, (as amended, restated, supplemented or otherwise modified from time to time, “IP Security Agreement”) in favor of **ROCKFORD CORPORATION**, an Arizona corporation (“Grantor”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the IP Security Agreement.

Pursuant to the IP Security Agreement, the Grantor granted to Lender a security interest (“Security Interest”) in such Grantor’s right, title and interest of every kind and nature in the Collateral listed on Schedule I attached hereto.

Lender now wishes to release and terminate the Security Interest and all right, title and interest in and to the Collateral under the IP Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Lender hereby releases and terminates all right, title and interest in, to, and under the IP Security Agreement in the Collateral, including, without limitation, the Security Interest.
