## **TRADEMARK ASSIGNMENT**

This Trademark Assignment (the "Assignment") is made and entered into effective the 30th day of November, 2022, by and between Stilt, Inc., a Delaware corporation ("Assignor") and JGW Lending, LLC, a Delaware limited liability company (the "Assignee") (collectively, the "Parties").

### **WITNESSETH:**

WHEREAS, Assignor is the owner of the trademark STILT which is the subject of United States federal trademark Registration No. 5655578, for "Providing temporary use of on-line non-downloadable software for initiating, conducting, monitoring and managing marketplace lending and financial transactions between lenders and borrowers" (hereinafter, the "Trademark");

WHEREAS, pursuant to an asset purchase agreement between the Parties, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to the Trademark, including common law rights, together with the goodwill of the business symbolized by the Trademark; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademark, including common law rights, together with the goodwill of the business symbolized by the Trademark.

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby grants, assigns and conveys to Assignee all of its right, title, and interest in and to the Trademark, including common law rights, together with the goodwill of the business symbolized by the Trademark. Assignee hereby accepts the Assignment of the Trademark as described herein.
2. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged or delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment.

3. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
