**TERMINATION AND RELEASE OF
NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), dated as of December 19, 2022, is executed by **BANK OF AMERICA, N.A.**, as administrative agent ("Administrative Agent"), and in favor of **GLOBALIZATION PARTNERS LLC**, a Delaware limited liability company ("Globalization Partners") and **GLOBALIZATION PARTNERS INTERNATIONAL LLC**, a Delaware limited liability company ("Globalization Partners International"), and together with Globalization Partners, collectively, jointly and severally, "Grantors" and each individually "Grantor". All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of February 16, 2021 (as amended, the "Security Agreement"), executed by Grantors in favor of Administrative Agent, Grantors granted to Administrative Agent a security interest in the Trademark Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on February 17, 2021, at Reel 7194 and Frame 0466, to evidence the security interest granted under the Security Agreement.

C. Administrative Agent agrees to terminate and release its security interest in the Trademark Collateral specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates and releases all of Administrative Agent's right, title and interest in pursuant to the Security Agreement, to and under the following (collectively, the "Trademark Collateral"):

(i) the trademarks and trademark applications shown on Schedule 1 attached hereto.

(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.

(c) Administrative Agent authorizes and requests the Trademark Division of the United States Patent and Trademark Office to record this Termination.
