**FULL RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

THIS FULL RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made and entered into as of December 16, 2022, by MERCHANT FINANCIAL CORPORATION (“Lender”), in favor of CLEAN BEAUTY FOR ALL, INC., a Delaware corporation (“Borrower”).

WHEREAS, Lender and Borrower entered into that certain Grant of Security Interest in Trademarks, dated as of August 6, 2021 (the “Security Agreement”), which was recorded with the United States Patent and Trademark Office on August 9, 2021, at reel and frame number 7382/0964; and
