**NOTICE OF TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN  
TRADEMARKS**

Dated as of December 21, 2022

This NOTICE OF TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made by **BANK OF AMERICA, N.A.**, as Administrative Agent (“Administrative Agent”) having an office located at 900 W. Trade Street, NC1-026-06-09, Charlotte, North Carolina 28255, in favor of **BACKYARD FARMS, LLC**, a Delaware limited liability company (“Grantor”), having its chief executive office at 2100 Road 4 East RR#2 Kingsville, Ontario, Canada N9Y 2E5.

WITNESSETH:

WHEREAS, reference is made to the U.S. Security and Pledge Agreement dated as of November 1, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Agreement”) among the Grantor, the other grantors party thereto and the Administrative Agent for the Secured Parties referenced therein, pursuant to which the Grantor granted a continuing security interest in and continuing lien upon the trademarks and trademark applications listed on Schedule 1 attached hereto (the “Trademark Collateral”) to the Administrative Agent for the ratable benefit of the Secured Parties; and

WHEREAS, in furtherance of the Agreement, the Grantor and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks dated as of July 28, 2017 (the “Trademark Notice”), which was which was duly recorded on July 31, 2017, at Reel/Frame 6117/0925 in the Trademark Division of the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without representation or warranty, hereby terminates, cancels, discharges and releases its security interest in and lien upon the Trademark Collateral and any right, title and interest of the Administrative Agent in the Trademark Collateral shall hereby cease. The Administrative Agent hereby re-transfers, re-conveys and re-assigns to the Grantor any right, title or interest it may have acquired in or to any of the Trademark Collateral. The Administrative Agent, without representation or warranty, hereby terminates and cancels the Trademark Notice.

The Grantor authorizes and requests that the Commissioner for Trademark of the United States Patent and Trademark Office record this Release. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

Capitalized terms used but not otherwise defined in this Release shall have the meanings given to such terms or given to such terms by reference in the Agreement or the Trademark Notice, as applicable.


