## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is dated as of December 20, 2022, by CIBC Bank USA, as administrative agent for certain lenders (“Administrative Agent”). Terms defined in the Collateral Agreement referred to below and not otherwise defined herein are used herein as defined in the Collateral Agreement.

WHEREAS, the Administrative Agent and AMP SECURITY, LLC a Utah limited liability company, AMP ALARM LLC, a Utah limited liability company and FREE60 LLC, a Utah limited liability company (each a "Grantor" and collectively, the "Grantors"), are parties to (i) that certain Amended and Restated Guaranty and Collateral Agreement dated as of June 9, 2020 (as amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the "Collateral Agreement"), and (ii) that certain Acknowledgment of Security Interest in Trademarks dated as of June 9, 2020 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the "Integrity Trademark Acknowledgment Agreement") (collectively, the "Security Documents");

WHEREAS, under the Security Documents, the Grantor granted the Administrative Agent a security interest in, among other things, certain Trademarks (the "Collateral"), including, without limitation, the Trademarks listed on Schedule 1 attached hereto, and the goodwill of the businesses with which the Collateral is associated, as security for certain obligations of the Grantor to the Administrative Agent and the other lenders;

WHEREAS, the Administrative Agent recorded the Trademark Acknowledgement Agreement on June 12, 2020 at Reel 6969, Frame 0401 with the United States Patent and Trademark Office Assignment Branch (Trademarks); and


WHEREAS, the Grantor has requested that the Administrative Agent release its security interests in the Collateral listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby fully discharges, releases and terminates its security interests in and liens on the Collateral listed on Schedule 1 hereto, and the goodwill of the businesses with which the Collateral is associated, and any right, title or interest of the Administrative Agent in the foregoing under the Security Documents shall hereby cease and become void.
