REASSIGNMENT AND RELEASE OF SECURITY INTEREST
(TRADEMARK SECURITY AGREEMENT)

This REASSIGNMENT AND RELEASE OF SECURITY INTEREST (TRADEMARK SECURITY AGREEMENT) (the “Release”) is made as of December 22, 2022, by WESTERN ALLIANCE BANK, an Arizona corporation (“Agent”) in favor of GRYPHON NETWORKS CORP., a Delaware corporation (“Grantor”).

Recitals

WHEREAS, Grantor granted to Agent a security interest in its Trademark Collateral (as defined in that certain Trademark Security Agreement between Agent and Grantor, dated as of January 29, 2021, as may be amended from time to time (the “Trademark Security Agreement”; capitalized terms not otherwise defined herein shall have the meanings assigned to such terms in the Trademark Security Agreement), and recorded with the US Patent and Trademark Office as set forth on Schedule 1 attached hereto), specifically including all of Grantor’s right, title and interest in, to and under the following:

(a) all of its registered trademarks and filed trademark applications, including, without limitation, those referred to on Schedule 1 hereto or on any Schedule to any Supplement delivered after the date of the Trademark Security Agreement, together with all renewals, reversions and extensions of the foregoing;

(b) all goodwill of the business connected with the use of, and symbolized by, each such trademark and trademark application covered by (a) above;

(c) all trademark applications, registrations, claims, awards, judgments, amendments, improvements and insurance claims related thereto now or hereafter owned or licensed by Grantor, or any claims for damages by way of any past, present, or future infringement of any of the foregoing, together with all accessions and additions thereto and proceeds thereof (including, without limitation, any proceeds resulting under insurance policies); provided, that, the Trademark Collateral shall include, without limitation, all cash, royalty fees, other proceeds, Receivables, accounts and general intangibles that consist of rights of payment to or on behalf of Grantor or proceeds from the sale, licensing or other disposition of all or any part of, or rights in, the Trademark Collateral by or on behalf of Grantor; and

(d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the “USPTO”) on August 6, 2021 at Reel 7387 and Frame 0792; and

WHEREAS, Grantor has no outstanding obligations to Agent under the terms of the Trademark Security Agreement, and Agent agrees to release its security interest in the Trademark Collateral.

Agreement

Now therefore, Agent agrees that it terminates, discharges and releases the entirety of any and all liens or its security interests in all of Grantor’s right, title and interest in, to and under Grantor’s Trademark Collateral, whether presently existing or hereafter acquired or created, pursuant to the Trademark Security Agreement and any right, title or interest of the Agent in such Trademark Collateral shall hereby terminate, cease and become void. The Agent hereby and reassigns, transfers and conveys any and all right, title and interest of the Agent in the Trademark Collateral to the Grantor and authorizes the Grantor or the Grantor’s authorized representative or designee to record this Release with the USPTO as evidence of such release and termination.
