PARTIES

ENZAFruit New Zealand International Limited, a New Zealand incorporated company having its registered office at 1 Clemow Drive, Mt Wellington, Auckland 1060 New Zealand ("Assignor")

Venturefruit Global Limited, a New Zealand incorporated company having its registered office at 1 Clemow Drive, Mt Wellington, Auckland 1060 New Zealand ("Assignee")

INTRODUCTION

- A. Assignor is the registered proprietor of the trademarks set out in Schedule 1 ("**Trade Marks**") as well as the goodwill associated with the Trade Marks.
- B. Pursuant to the agreement for sale and purchase of certain assets dated on 23 December 2020 between the Assignor and the Assignee ("**Agreement**"), the Assignor has agreed to assign the Trade Marks to the Assignee.
- C. Assignor has agreed to assign, and Assignee wishes to receive, all rights, title and interest in the Trade Marks and the goodwill associated with the Trade Marks on the terms and conditions set out in this deed.

COVENANTS

1. ASSIGNMENT

- 1.1 On and from 1 January 2021, in consideration for the sum of NZD\$1.00 (the receipt and sufficiency of which is hereby acknowledged by Assignor), the Assignor assigns, transfers and sets over to Assignee its entire right, title, interest and benefit in and to the Trade Marks and all its rights, remedies, powers and associated goodwill in relation to those Trade Marks, to hold, use, exercise and enjoy to and for Assignee absolutely.
- 1.2 Other than approved by the Assignee, the Assignor shall cease all use of the Trade Marks as from 1 January 2021.
- 1.3 All costs associated with the assignment of the Trade Marks (as set out in this deed) shall be met by Assignee.

2. COUNTERPARTS

- 2.1 This deed may be executed in counterparts or duplicates, each shall be considered an original and one and the same instrument. This deed shall not be effective until each party has executed and delivered at least one counterpart.

3. FURTHER ASSURANCES


3.1 Assignor shall, at the request and expense of Assignee (as to out of pocket expenses only), execute promptly all such assignments, deeds or documents and do promptly all such things as Assignee may deem necessary or desirable to vest or perfect the vesting of the Trade Marks or goodwill in the Trade Marks in Assignee.

4. LAW AND JURISDICTION

4.1 This deed shall be governed by New Zealand law, and the parties shall submit to the non-exclusive jurisdiction of the New Zealand courts.


