TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 23, 2022 (“Release”), is made by KeyBank National Association, as Administrative Agent (“Administrative Agent”), in favor of HealthCo Information Systems, LLC, an Oregon limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Collateral Agreement dated as of December 16, 2020 (as amended, restated, amended and restated, extended, supplemented or otherwise modified from time to time, the “Collateral Agreement”) by and among the Grantor, Administrative Agent, and other Persons party thereto and the Trademark Security Agreement dated as of December 16, 2020 (“Trademark Security Agreement”) by and among the Grantor and Administrative Agent, Grantor pledged to the Administrative Agent, its successors and assigns for the benefit of the Secured Parties, and granted to the Administrative Agent, its successors and assigns for the benefit of the Secured Parties, a security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on December 16, 2020 at Reel 7210 Frame 0286.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Collateral Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York
