## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (“Assignment”) is made and entered into effective as of July 5, 2022 (the “Effective Date”) by **Absolute Coatings, Inc.**, a Delaware corporation (the “Assignor”) in favor of **Polycare Supply Group LLC**, a New Jersey limited liability company (the “Assignee”) having an address at 125 Market Street, Kenilworth, New Jersey 07033.

### RECITALS

WHEREAS, Assignor is the sole and exclusive owner of all right, title and interest in and to the Trademark POLY-CARE, currently the subject of U.S. trademark registration no. 1574242 on file with the United States Patent and Trademark Office (the “Trademark”), together with the goodwill of the business symbolized by the Trademark.

WHEREAS, pursuant to the terms of that certain Trademark Transfer and Product Supply Agreement, dated as of January 1, 2022, by and between Assignor and Assignee, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all of Assignor’s right, title and interest in and to the Trademark, together with any and all goodwill of the business symbolized therewith.


NOW THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Assignor hereby agrees as follows:

1. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor’s rights, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark.
2. This Assignment shall inure to the benefit of Assignee and its successors and assigns and shall be binding upon Assignor and its successors and assigns.
3. Assignor agrees to undertake any other acts, and shall execute, acknowledge and/or deliver any other instruments, documents or other materials as may be reasonably required in order to consummate the transaction and perfect and enforce the rights assigned to Assignee in this Assignment.
4. This Assignment and all questions relating to its validity, interpretation, performance and enforcement shall be governed by and construed in accordance with the laws of the State of New Jersey, United States of America. This Assignment has been executed pursuant to the Trademark Transfer and Product Supply Agreement and is subject to all terms and provisions thereof. In the event of any conflict or inconsistency between the terms of the Trademark Transfer and Product Supply Agreement and the terms hereof, the terms of the Trademark Transfer and Product Supply Agreement shall govern.
