**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of December 28, 2022, by **BMO HARRIS BANK N.A.**, a United States national association (in such capacity, together with its successors and assigns, “Agent”) in favor of **VALENTINE ROOFING, LLC**, an Delaware limited liability company with an address at 400 Industry Drive, Suite 130, Tukwila, Washington 98188 (“Grantor”).

W I T N E S S E T H:

WHEREAS, Grantor entered into a certain trademark security agreement dated October 7, 2022 (the “Trademark Security Agreement”) with Agent, notice of which was submitted to the United States Patent and Trademark Office for recording on October 7, 2022 at Reel 7861, Frame 0989.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Agent, under the terms of the Trademark Security Agreement and the Security Agreement (as defined in the Loan Agreement), a continuing security interest (the “Security Interest”) in favor of the Agent, in all of its right, title and interest in and to the Trademark Collateral, including without limitation the trademarks listed in **Schedule A**.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby (i) fully releases, terminates, relinquishes and discharges any and all of its interest in the Trademark Collateral of the Grantor, including all of the goodwill of such Grantor’s business symbolized by the Trademark Collateral and associated therewith, (ii) assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and (iii) authorizes and requests that the USPTO note and record the release hereby given and any other filing necessary to evidence the release and termination of the Agent’s rights under the Trademark Security Agreement with respect to the Trademark Collateral.
