**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of December 21, 2022, by **SILICON VALLEY BANK**, a California corporation (“**Bank**”) in favor of **GROVE COLLABORATIVE, INC.**, a Delaware public benefit corporation (“**Grantor**”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated December 1, 2016 (as amended and/or supplemented from time to time hereinafter, “**Agreement**”), granting to Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Intellectual Property Collateral (as defined in the Agreement), which was recorded with the Trademark division of the United States Patent and Trademark Office on December 6, 2016 at Reel 5935, Frame 0578, as supplemented pursuant to an Addendum to Intellectual Property Security Agreement dated as of July 29, 2020 which was recorded with (i) the Patent division of the United States Patent and Trademark Office on July 30, 2020 at Reel 053353, Frame 0253, and (ii) the Trademark division of the United States Patent and Trademark Office on July 30, 2020 at Reel 7011, Frame 0677 and a Supplement to Intellectual Property Security Agreement dated as of April 30, 2021 which was recorded with (i) the Patent division of the United States Patent and Trademark Office on April 30, 2021 at Reel 056096, Frame 0402, and (ii) the Trademark division of the United States Patent and Trademark Office on April 30, 2021 at Reel 7276, Frame 0314 and a Supplement to Intellectual Property Security Agreement was recorded with the Trademark division of the United States Patent and Trademark Office on May 10, 2022 at Reel 7734, Frame 0535;

**WHEREAS**, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Intellectual Property Collateral as herein provided; and

**WHEREAS**, Grantor has requested that the Bank provide a document suitable for recording with the United States Patent and Trademark Office (the “**USPTO**”) to evidence the release of the Bank’s security interests in and liens on the Intellectual Property Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, those patents, trademarks, patent applications and/or trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO by the Grantor or its designee, including any new lender of the Grantor.



