**TERMINATION AND RELEASE OF INTELLECUTAL PROPERTY SECURITY
AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of December 21, 2022, by **SILICON VALLEY BANK**, a California corporation, in its capacity as administrative agent and collateral agent (“**Agent**”) in favor of **GROVE COLLABORATIVE, INC.**, a Delaware corporation (“**Grantor**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated April 30, 2021 (as amended and/or supplemented from time to time hereinafter, the “**Agreement**”) in favor of the Agent, for the ratable benefit of the Lenders, pursuant to which Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral, which was recorded with the Trademark division of the United States Patent and Trademark Office on April 30, 2021 at Reel 7276, Frame 0289 and the Patents division of the United States Patent and Trademark Office on April 30, 2021 at Reel 056096, Frame 0316 and a Supplement to Intellectual Property Security Agreement was recorded with the Trademark division of the United States Patent and Trademark Office on July 22, 2022 at Reel 7765, Frame 0746;

WHEREAS, Grantor has requested that Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Intellectual Property Collateral as herein provided; and

WHEREAS, Grantor has requested that the Agent provide a document suitable for recording with the United States Patent and Trademark Office (the “**USPTO**”) to evidence the release of the Agent’s security interests in and liens on the Intellectual Property Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, those patents, trademarks, patent applications and/or trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO by the Grantor or its designee, including any new lender of the Grantor.


