CONFIRMATORY ASSIGNMENT OF INTELLECTUAL PROPERTY

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of March 29, 2022 (the "Effective Date"), is between Cenveo Worldwide Limited, (a Delaware corporation) with its principal office at 200 First Stamford Place, 2nd Floor, Stamford, CT, 06902 and, LightningLabels.com LLC (a Delaware limited liability company), with a previous address at 200 First Stamford Place, 2nd Floor, Stamford, CT, 06902, now with its principal office at 2369 S. Trenton Way, Unit C, Denver CO 80231 both, ("Assignors") and Brook & Whittle Limited, (a Delaware corporation) with its principal office at 20 Carter Drive, Guilford, CT, 06437; ("Assignee").

WITNESSETH:

WHEREAS, Assignors are the owners of all right, title and interest in and to the Trademarks, Patents, Copyrights and other Intellectual Property and Registrations therefore described on Schedule A attached hereto (hereinafter referred to collectively as the "Properties") and all of the goodwill of the businesses associated therewith.

WHEREAS, for good and valuable consideration and pursuant to that certain Asset and Membership Interest Purchase Agreement dated as of the Effective Date by and among Assignors and Assignee (the "Purchase Agreement"), and upon the terms and conditions set forth below, Assignee proposes to acquire all rights, title and interest in and to said Properties described on Schedule A as of the Effective Date;

NOW, THEREFORE, in consideration of the transactions contemplated by the "Purchase Agreement" and this Assignment and of other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignors hereby assign, grant, transfer and otherwise convey to Assignee, its successors and assigns, the entire right, title and interest in and to said Properties listed on the attached Schedule A, including but not limited to all of Assignors' common law rights and registrations pertaining thereto, as well as all of the goodwill of the business symbolized by said Properties are used, including without limitation, the right to any registrations thereof, the right to prosecute any applications therefor, the right to have any registrations issue in the name of the Assignee, the right to apply for and obtain any renewal of any registrations thereof, the right to any priorities based on the filing of the aforesaid applications, the right to all continuations, divisional or other priority or related applications and foreign counterparts or applications claiming priority to the said Properties, the right to sue for past, present and future infringement, misappropriation and any other violation of any of the Properties listed on the attached Schedule A.

2. Further Assurances. Assignee shall have the right to record this Assignment with all applicable governmental authorities and registrars so as to perfect its ownership of the Properties. Assignors agrees to assist Assignee and its successors and assigns, at Assignee's cost and expense, to secure the Properties, including by executing all applications, specifications, oaths, assignments and all other instruments which Assignee shall deem necessary in order to apply for, obtain, maintain, and transfer all right, title, and interest to such Properties to Assignee and for the purpose of enforcing or defending Assignee's complete, exclusive, and worldwide ownership of all right, title and interest in and to the Properties.

For the convenience of the parties any number of counterparts hereof may be executed, and each such executed counterpart shall be deemed an original, and all such counterparts together shall constitute one and the same instrument. Facsimile transmission of an executed counterpart of this Agreement shall be deemed to constitute due and sufficient delivery of such counterpart, and such facsimile signatures shall be deemed original signatures for purposes of enforcement and construction of this Agreement.


