RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, effective as of December 21, 2022, is given by DWIGHT FUNDING LLC (“DWIGHT”), with its principal offices at 787 11th Ave, 10th Floor, New York, NY 10019, to NATPETS, LLC, a Colorado limited liability company (“Company”), with its principal offices at 2108 55th Street, Suite 100, Boulder, CO 80301, as follows:

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of October 19, 2018, by and among Company, certain of its affiliates, and Dwight, as amended from time to time (the “Security Agreement”), a security interest was granted by Company to Dwight in certain intellectual property owned by the Company, including without limitation those items listed on Schedule 1 hereto (the “Trademarks”);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on December 11, 2018, at Reel 006503, Frame 0568; and

WHEREAS, the obligations under the Security Agreement having been satisfied, Dwight desires to memorialize the release of the entirety of its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Dwight hereby terminates the security interest and releases, and discharges to Company the continuing security interest in, and any other interest Dwight may have in the Company’s right, title and interest in and to the Trademarks and all other intellectual property owned by the Company.
