TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT** (this “Agreement”), dated as of December 23, 2022, is entered into by the undersigned (collectively, the “Grantors”) in favor of **JPMORGAN CHASE BANK, NATIONAL ASSOCIATION**, a national banking association chartered under the laws of the United States of America, in its capacity as administrative agent (together with its successors and permitted assigns, the “Administrative Agent”) for the benefit of itself and the other lenders from time to time party to the Loan Agreement (as defined below) (together with their respective successors and permitted assigns, collectively, the “Lenders”; and, together with Administrative Agent, collectively, the “Secured Party”).

WHEREAS, the Grantors and the Secured Party have entered into that certain Construction Loan and Security Agreement (the “Loan Agreement”), dated as of even date herewith; and

WHEREAS, pursuant to the Loan Agreement, the Grantors, the Administrative Agent and certain other parties have entered into (i) that certain Amended and Restated Fee Deed of Trust, Security Agreement, Assignment of Leases and Fixture Filing (the “Fee Deed and Security Agreement”) and (ii) that certain Leasehold Deed of Trust, Security Agreement, Assignment of Leases and Fixture Filing (the “Leasehold Deed and Security Agreement”; together with the Fee Deed and Security Agreement, collectively, the “Deed and Security Agreement”), each dated as of even date herewith, pursuant to which the Grantors have agreed to grant to the Administrative Agent, for the benefit of the Secured Party, a security interest in all of the Grantors’ rights, titles, and interests in and to the Trademark Collateral (as defined below).

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantors and the Administrative Agent hereby agree as follows:

SECTION 1. Defined Terms. Capitalized terms not otherwise defined herein have the meanings set forth in the Deed and Security Agreement.

SECTION 2. Grant of Security Interest. The Grantors hereby collaterally assign, grant, mortgage and pledge to the Administrative Agent, for the benefit of the Secured Party, a security interest in and lien on all of the following property now owned or at any time hereafter acquired by the Grantors or in which the Grantors now have or at any time in the future may acquire any right, title or interest and wherever the same may be located (collectively, the “Trademark Collateral”), as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Grantors’ Obligations (including any extensions, modifications, substitutions, amendments or renewals of any or all of such Obligations):

- (i) all U.S. federal trademarks, service marks, trade dress, certification marks and collective marks, all registrations and recordings thereof, and all applications in connection therewith, in each case to the extent registered, recorded or applied for in the United States Patent and Trademark Office, including any of the foregoing referred to on Schedule A attached hereto, and all rights corresponding

thereto throughout the world (including all licenses and permissions related thereto in the Las Vegas, Nevada metropolitan statistical area);

(ii) all of the goodwill of the business connected with the use of and symbolized by the foregoing;

(iii) all extensions and renewals of the foregoing;

(iv) the right to sue or otherwise recover for any past, present and future infringement, dilution, or other violation of any of the foregoing or for any injury to goodwill;

(v) all proceeds (as defined in Section 9-102(a)(64) of the Delaware UCC and, in any event, including all income therefrom, collections thereon or distributions or payments with respect thereto), including license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect to any of the foregoing;

(vi) all corresponding rights under applicable law in the United States; provided, however, that the foregoing shall not include any “intent-to-use” Trademark application prior to the filing of a “Statement of Use” or “Amendment to Allege Use” with respect thereto, to the extent, if any, that, and solely during the period, if any, in which the grant of a security interest therein would impair the validity or enforceability of such intent-to-use Trademark application under applicable federal law; and

(vii) the Intellectual Property License Agreement, dated as of November 30, 2022, by and between IP Brandco LLC and Bowtie Hospitality LV LLC, each a Delaware limited liability company, and pursuant to that certain Consent and Agreement (Intellectual Property License Agreement), dated as of the date hereof, by and among Grantors, Jeffrey Soffer, IP Brandco LLC and Bowtie Hospitality LV LLC, and Administrative Agent on behalf of Secured Party.

SECTION 3. Recordation. The Grantors authorize and request that the Commissioner for Trademarks and any other applicable government officer record this Agreement.

SECTION 4. Governing Law. This Agreement and the rights and obligations of the parties under this Agreement shall be governed by, and construed and enforced in accordance with, the Laws of the State of New York without regard to conflict of laws principles that would require application of the laws of another jurisdiction.

SECTION 5. Counterparts. This Agreement may be executed in any number of counterparts (including by telecopy or .pdf), each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


