TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of December 18, 2022, and made by **BANK OF MONTREAL**, as collateral agent (the "Collateral Agent") in favor of **NAVACORD CORP., BENEFITS DIRECT CORP., DEHONEY FINANCIAL GROUP LTD., LLOYD SADD INSURANCE BROKERS LTD., SAFETY INSURANCE SERVICE (1959) LTD., SELECTPATH BENEFITS & FINANCIAL INC., THOMAS I. HULL INSURANCE LIMITED AND TRIPOINT INSURANCE UNERWRITING INC.** (each a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of March 26 2021, and made by the Grantors in favor of Collateral Agent (the "Security Agreement"), a security interest was granted by the Grantors to Collateral Agent in certain Trademark Collateral (as defined therein), including the trademarks listed therein;


WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 26, 2021 at Reel/Frame 7234/0936; and

WHEREAS, Collateral Agent now desires to terminate and release the Security Agreement;




NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Collateral Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral, including the trademarks set forth in Schedule A hereto, and reassigns to the person or persons legally entitled thereto all right, title and interest of Collateral Agent in the Trademark Collateral.



