ASSIGNMENT OF TRADEMARKS

WHEREAS, the Assignor and the Assignee have entered into a certain Asset Purchase Agreement of even date herewith, pursuant to which the Assignor has agreed to sell to the Assignee, and the Assignee has agreed to purchase from the Assignor, certain assets, including the Trademarks.

NOW, THEREFORE, in consideration of the foregoing, as well as other good and valuable consideration, the receipt and adequacy of which is hereby freely acknowledged, and intending to be legally bound hereby, the Assignor and the Assignee do hereby agree:

1. The Assignor hereby assigns, grants and conveys to the Assignee, and its successors and assigns, all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by and associated with said Trademarks, and the right to sue, recover and retain damages (and costs and attorneys' fees) for present and past infringements and unauthorized uses of any of the Trademarks.

2. Assignor authorizes and requests the applicable intellectual property office or other governmental authorities in all applicable jurisdictions, whose duty is to issue trademark registrations, to issue the same to Assignee and to record Assignee as owner of the Trademarks, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

3. The Assignor will, upon request of the Assignee, execute any other documents which may be necessary or appropriate to perfect in the Assignee the rights, title and interest herein conveyed in the jurisdictions identified in Schedule A or any other country.


4. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same instrument.
