**PARTIAL RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Partial Release of First Lien Security Interest in Trademarks (“Release”) is made as of December 30, 2022, by **GOLDMAN SACHS LENDING PARTNERS LLC**, a Delaware limited liability company (the “First Lien Collateral Agent”) in favor of **UNIVISION RADIO FLORIDA, LLC**, a Delaware limited liability company with an address at 3102 Oak Lawn Avenue, Suite 215, Dallas, Texas 75219 (the “Grantor”).

WHEREAS, the Grantor granted the First Lien Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the First Lien Collateral Agent, in and to its Trademark Collateral, including the Trademarks listed in Schedule 1.

WHEREAS, the First Lien Collateral Agent has agreed to terminate and release its security interest in the Trademarks listed in Schedule 1 as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the First Lien Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks listed in Schedule 1 hereto.
