**PARTIAL RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Partial Release of First Lien Security Interest in Trademarks (“Release”) is made as of December 30, 2022, by **GOLDMAN SACHS LENDING PARTNERS LLC**, a Delaware limited liability company (the “First Lien Collateral Agent”) in favor of **UNIVISION COMMUNICATIONS INC.**, a Delaware corporation with an address at 5999 Center Drive, Los Angeles, California 90045, and **UNIVISION RADIO, LLC**, a Delaware limited liability company with an address at 8551 NW 30th Terrace, Miami, Florida 33122 (each, a “Grantor”, and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into that certain first lien trademark security agreement supplement dated June 24, 2022 (the “Trademark Security Agreement”) with First Lien Collateral Agent, notices of which were recorded on June 24, 2022 at the United States Patent and Trademark Office at Reel 7762, Frame 0233, Reel 7762, Frame 0253 and Reel 7762, Frame 0291.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantors granted the First Lien Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the First Lien Collateral Agent, in and to their Trademark Collateral, including the Trademarks listed in Schedule 1.

WHEREAS, the First Lien Collateral Agent has agreed to terminate and release its security interest in the Trademarks listed in Schedule 1 as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the First Lien Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks listed in Schedule 1 hereto.
