- b) The "FBOMB" word trademark registered with the United States Patent and Trademark Office as Reg. No. 4983018;
- c) The "FAT IS SMART FUEL" design trademark registered with the United States Patent and Trademark Office as Reg. No. 4983021;
- d) The "KETO KRUNCH" word trademark registered with the United States Patent and Trademark Office as Reg. No. 6048425;
- e) The "REAL NUTTY" word trademark registered with the United States Patent and Trademark Office as Reg. No. 6603937;

collectively referred to as the "Licensed Marks."

Notwithstanding anything to the contrary contained herein, this Assignment is not intended to enlarge or reduce the rights of the parties under the Purchase Agreement, but is intended to carry out the terms of such Agreement.

This Assignment shall be (a) binding upon and inure to the benefit of the parties hereto and their respective successors and assigns, and (b) governed by and construed in accordance with the laws of the State of Arizona, without reference to any choice of law principles.

This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall be one and the same instrument.
