**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

TERMINATION AND RELEASE, dated as of December 30, 2022, from BARCLAYS BANK PLC, as collateral agent and administrative agent for the Secured Parties (in such capacity, and together with its successors and assigns in such capacity, the “Agent”) for the banks and other financial institutions (the “Lenders”) that are parties to the Credit Agreement (as hereinafter defined), to Ouray Sportswear, LLC, a Colorado limited liability company (as successor-in-interest to Recollect Threads Ltd.) (the “Grantor”). Capitalized terms used herein without definition are used as defined in the First Lien Cash Flow Credit Agreement, dated as of March 11, 2021, among the Agent, the Grantor, the Parent Borrower and the Lenders (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”).

**WITNESSETH:**

WHEREAS, pursuant to that certain First Lien U.S. Guarantee and Collateral Agreement, dated as of March 11, 2021 (the “Security Agreement”), the Grantor granted to the Agent for the benefit of the Secured Parties, a security interest in all of its Pledged Trademarks (as hereinafter defined) (the “Security Interest”); and

WHEREAS, the Grantor duly authorized the execution, delivery and performance of the Notice and Confirmation of Grant of Security Interest in Trademarks that was recorded in the Trademark Division of the United States Patent and Trademark Office on November 22, 2021 at Reel 7502, Frame 0411;

WHEREAS, the Grantor duly authorized the execution, delivery and performance of the Notice and Confirmation of Grant of Security Interest in Trademarks that was recorded in the Trademark Division of the United States Patent and Trademark Office on November 22, 2021 at Reel 7502, Frame 0381; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Pledged Trademarks;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Pledged Trademarks pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. **Pledged Trademarks:** The term “Pledged Trademarks,” as used herein, shall mean, all of the Grantor’s right, title and interest in and to all Trademarks (as defined in the Security Agreement) (including, without limitation, those items listed on

Schedule I hereto) and, to the extent not otherwise included, all Proceeds and products of any and all of the foregoing.

2. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Pledged Trademarks, and any right, title or interest of the Agent in such Pledged Trademarks shall hereby cease and become void.

3. Further Assurances: The Agent shall execute and deliver to the Grantor all further releases and other documents (including without limitation Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of such Security Interest.


