TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “**Agreement**”) dated as of this 15 day of November, 2022 between **WE’VE ONLY JUST BEGUN WEDDING CHAPEL, INC.** d/b/a A Little White Chapel and/or A Little White Wedding Chapel, a Nevada corporation, having an address of 1301 S. Las Vegas Blvd., Las Vegas, Nevada 89104 (“**Assignor**”), and **LAS VEGAS WEDDING BUREAU, LLC**, a Nevada limited liability company, having an address of 555 S. 3rd Street, Las Vegas, Nevada 89101 (“**Assignee**”). Assignor and Assignee hereinafter individually a “**Party**” and together the “**Parties**”.

WHEREAS, Assignor and Assignee entered into that certain Asset Purchase and Sale Agreement on July 20, 2022 (the “**Purchase Agreement**”) pursuant to which Assignee is acquiring all right, title and interest in and to Assignor’s business operation commonly known as A Little White Chapel and/or A Little White Wedding Chapel; and

WHEREAS, in connection with the Purchase Agreement, Assignor desires to assign to Assignee, and Assignee desires to accept and assume, all of Assignor’s right, title and interest in and to the Assigned Marks (as defined below).

NOW, THEREFORE, for the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby irrevocably transfers and assigns to Assignee, and Assignee hereby accepts and assumes from Assignor, all of Assignor’s right, title and interest in and to (i) the trademarks set forth in Exhibit A hereto, (ii) any trademark, service mark, trade name, domain name or other source identifier that is a derivative of or confusingly similar to any of the trademarks set forth in Exhibit A hereto, (iii) any other trademark, service mark, trade name, domain name or other source identifier that contains the term “A Little White Chapel and/or A Little White Wedding Chapel”, or any term, design or other source identifier that is a derivative of or confusingly similar to the term “A Little White Chapel and/or A Little White Wedding Chapel”, (iv) any registration or application for registration of any of the foregoing, and (v) any goodwill associated with any of the foregoing (collectively, the “**Assigned Marks**”).

2. Cooperation. The Parties shall, and shall cause their employees, affiliates, successors and assigns to, execute all documents and take all additional steps reasonably necessary to effect the intent of this Agreement.

3. DISCLAIMER; LIMITATION OF LIABILITY. NOTWITHSTANDING ANYTHING IN THIS AGREEMENT TO THE CONTRARY, THE ASSIGNED MARKS ARE ASSIGNED AND ASSUMED ON AN “AS IS” BASIS WITH NO REPRESENTATIONS OR WARRANTIES, AND ASSIGNOR HEREBY EXCLUDES AND DISCLAIMS ANY EXPRESS OR IMPLIED REPRESENTATIONS OR WARRANTIES OF ANY KIND WITH RESPECT TO THE ASSIGNED MARKS, INCLUDING THOSE REGARDING MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT AND ANY WARRANTIES IMPLIED BY ANY COURSE OF DEALING OR TRADE USAGE. ASSIGNOR SHALL NOT BE LIABLE UNDER ANY LEGAL OR EQUITABLE THEORY

FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR EXEMPLARY DAMAGES OF ANY KIND IN CONNECTION WITH THIS AGREEMENT EVEN IF ASSIGNEE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.


4. General Provisions. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument. This Agreement (along with its Exhibit) and the Purchase Agreement constitutes the entire understanding and agreement of the Parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the Parties with respect thereto. This Agreement may not be supplemented, altered, or modified in any manner except by a writing signed by the Parties. The failure of a Party to enforce any terms or provisions of this Agreement shall not result in the waiver by such Party of any of its rights under such terms or provisions. If any provision of this Agreement is determined to be invalid or unenforceable, then the remainder of the Agreement shall remain valid and enforceable as if the Agreement did not contain the invalid or unenforceable provision.

5. Governing Law. This Agreement shall be subject to and governed by the laws of the State of Nevada without regard to the conflict of law rules of such state.



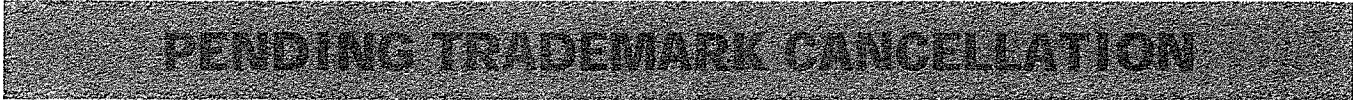
