CLARIFICATION OF THE ASSIGNMENT DOCUMENTS

We received the Notice of Non-Recordation as attached. We believe the Notice is due to a misunderstanding based on a very confusing Spanish government document, the translation of which is attached.

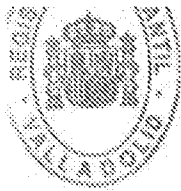
In this matter, the company name changed from Hijos de Antonio Barcelo, S.A. to Grupo Bodegas Palacio 1894 S.A. (as captured in the attached cover sheet) in 2017. Then, in 2021, the name was changed again from Grupo Bodegas Palacio 1894 S.A. to Entrecanales Domecq e Hijos S.A.

We asked for a government document to reflect the 2017 name change. Attached is a translation of a February 2022 document. In the translation, the first paragraph reminds us that the company is now called Entrecanales Domecq e Hijos S.A. (in bold no less, drawing significant attention to a fact that is irrelevant to his name change filing). The second paragraph identifies the name change reflected in our cover sheet (Hijos to Grupo). The Notice of Non-Recordation focuses on the first paragraph (which does not explicitly identify a name change, but rather identifies a current name and an original name), but the document is filed to reflect the information disclosed in the second paragraph.

We did file a different name change document to capture the 2021 name change from Grupo Bodegas Palacio 1894 S.A. to Entrecanales Domecq e Hijos S.A., so that the whole chain of title is clear.

Please review this matter. I can completely understand why the translation was misunderstood and the Notice was issued, but the cover letter is correct and does reflect the sole name change explicitly identified in the translated document.

For ease of reference, the relevant section of the assignment document in Spanish:






