RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE dated as of December 14, 2022 (this “Release”) is made by SIENA LENDING GROUP LLC, as Lender (in such capacity, the “Lender”) under that certain Intellectual Property Security Agreement, dated as of April 6, 2021, among VVF INTERVEST, LLC, a Nevada limited liability company (“Intervest”), VVF, LLC, a Nevada limited liability company (“VVF”), VVF ILLINOIS, LLC, an Illinois limited liability company (“Illinois”), VVF ILLINOIS SERVICES, LLC, an Illinois limited liability company (“Illinois Services”), VVF KANSAS, LLC, a Nevada limited liability company (“Kansas”), VVF KANSAS SERVICES, LLC, a Nevada limited liability company (“Kansas Services”), OHIO SOAP, LLC, an Ohio limited liability company (“Ohio Soap”), VVF OHIO INC., a Delaware corporation (“Ohio”), ST. BERNARD SOAP COMPANY, a Delaware corporation (“St. Bernard”) and VVF Cincinnati, LLC, a Delaware limited liability company (“Cincinnati”) and together with St. Bernard, Ohio, Ohio Soap, Kansas Services, Kansas, Illinois Services, Illinois, VVF and Intervest, collectively, the “Grantors” and each individually, a “Grantor”) and the Lender.

WHEREAS, pursuant to the IP Security Agreement, which was recorded on May 27, 2021 at Reel/Frame: 7355/0001 with respect to the Trademarks listed therein, the Grantor granted to the Lender a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademarks (as defined in the IP Security Agreement and for purposes of this release, the “Released Collateral”), which includes those set forth on the attached Schedule 1; and

WHEREAS, the Grantor has requested and the Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate all of the liens and security interest created under the IP Security Agreement in the Released Collateral, (b) release all of its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
