Pursuant to Title 8, Section 253 of the General Corporation Law of the State of Delaware, Appspace, Inc., a corporation incorporated on the 31st day of July, 2012, pursuant to the provisions of the General Corporation Law of the State of Delaware (the “Corporation”);

DOES HEREBY CERTIFY that the Corporation owns 100% of the capital stock of Beezy Inc., a corporation incorporated on the 15th day of April, 2013, as amended, pursuant to the provisions of the General Corporation Law of the State of Delaware (“Beezy”), and that the Corporation, by a resolution of its board of directors (“Board of Directors”) duly adopted by written consent on December 22, 2022, determined to and approved the merger into itself of said Beezy, which resolution is in the following words to wit:

WHEREAS, the Corporation is the holder, beneficially and of record, of all the issued and outstanding capital stock of Beezy;

WHEREAS, the Board of Directors of the Corporation has determined that it is in the best interest of the Corporation for Beezy to merge with and into the Corporation, with the Corporation surviving the merger (the “Appspace Beezy Merger”); and

WHEREAS, the Board of Directors of the Corporation has been presented with and reviewed an Agreement and Plan of Merger by and between the Corporation and Beezy (the “Appspace Beezy Merger Agreement”).

NOW THEREFORE, BE IT RESOLVED, that the Board of Directors of the Corporation hereby approves, adopts and declares advisable, the Appspace Beezy Merger and the Appspace Beezy Merger Agreement substantially in the form presented to the Board of Directors, together with any changes and modifications thereto as may be deemed necessary or appropriate by the officers of the Corporation, as conclusively evidenced by any such officer's execution and delivery thereof; and be it

FURTHER RESOLVED, that the officers of the Corporation be, and each of them hereby is directed to make and execute a Certificate of Ownership setting forth a copy of the resolution to merge with Beezy and assume its liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of the State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of New Castle County, Delaware; and be it

FURTHER RESOLVED, that the Certificate of Ownership and the Appspace Beezy Merger shall be effective on December 31, 2022 at 11:59 pm EST; and be it

FURTHER RESOLVED, that the officers of the Corporation be, and each of them hereby is, authorized and empowered, in the name and on behalf of the Corporation, to make all such arrangements, to do and perform all acts and things, and to execute and deliver all agreements and documents as any such officer may deem necessary or appropriate in order to effectuate the Appspace Beezy Merger, and any and all actions taken heretofore and hereafter to accomplish such purpose, be, and hereby are, approved, ratified and confirmed.
