ASSIGNMENT

WHEREAS, Sagamore Insurance Company, an Indiana Corporation, having its principal place of business at 111 Congressional Boulevard, Suite 500, Carmel, Indiana 46032, is the owner of certain trademark registrations set forth on Schedule C; and

WHEREAS, Progressive Casualty Insurance Company (“**ASSIGNEE**”), an Ohio Corporation, having its principal place of business at 6300 Wilson Mills Road, Mayfield Village, Ohio 44143, wishes to acquire the entire right, title and interest in and to the aforementioned trademark registrations, including any and all goodwill symbolized thereby (collectively, the “**Intellectual Property**”) in any and all countries;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound hereby, Protective Insurance Corporation, Protective Insurance Company, and Sagamore Insurance Company (collectively, the “**ASSIGNORS**”) do hereby sell, assign, transfer and set over to ASSIGNEE, and ASSIGNEE hereby accepts, the entire right, title and interest, including the right to claim priority, in and to the Intellectual Property, together with the goodwill symbolized thereby, and any and all continuations, divisions and renewals of and substitutes for the Intellectual Property, and to trademark applications or trademark registrations, which may be granted on or as a result thereof in the United States and any and all other countries, and any renewals of trademark registrations, and the full right to sue for and recover damages recoverable for past infringement of the same, and for violations of provisional rights having arisen from any published applications for the Intellectual Property.

Each ASSIGNOR further assigns to and authorizes ASSIGNEE to file corresponding applications for trademarks in all countries, in ASSIGNEE’s discretion, to be held and enjoyed by ASSIGNEE, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which the Intellectual Property respectively may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by the ASSIGNORS had this assignment, sale and transfer not been made.

Each ASSIGNOR hereby covenants, warrants and represents that it has full right and authority to convey the entire interest to the Intellectual Property herein assigned, and that no ASSIGNOR has executed, and will not execute, any agreement in conflict herewith. Each ASSIGNOR further covenants, warrants and represents that it will each time request is made and without undue delay, execute and deliver all such papers as may be necessary or desirable to perfect the title to said Intellectual Property in ASSIGNEE, its successors, assigns, nominees, or legal representatives, and each ASSIGNOR agrees to communicate to ASSIGNEE or to its nominee all known facts respecting the Intellectual Property, to testify in any legal proceedings, to sign all lawful papers to execute all disclaimers and divisional, continuing, reissue and foreign applications, to make all rightful oaths, and generally to do everything reasonably possible to aid ASSIGNEE, its successors, assigns, nominees and legal representatives to obtain and enforce for its or their own benefit proper protection for the Intellectual Property in any and all countries, all at the expense, however, of ASSIGNEE, its successors, assigns, nominees or legal representatives.

ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to issue trademark registrations on applications as aforesaid, to issue to ASSIGNEE, as assignee of the entire right, title and interest in and to the Intellectual Property, all appropriate trademark registrations evidencing ASSIGNEE's rights in and to the Intellectual Property as described herein.
