PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT

This **PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT**, dated as of October 31, 2022 (“**Partial Release**”), is made by BANK OF AMERICA, N.A., as collateral agent, together with its successors and permitted assigns (the “**Collateral Agent**”) in favor of PHIBRO ANIMAL HEALTH CORPORATION, a Delaware corporation (the “**Borrower**”), and the others Persons listed on the signature pages of the Security Agreement (as defined below) (together with the Borrower, each a “**Grantor**”).

RECITALS

WHEREAS, each Grantor agreed, pursuant to a Security Agreement, dated as of June 29, 2017, in favor of the Collateral Agent (the “**Security Agreement**”), to guarantee the Obligations of the Borrower, and

WHEREAS, pursuant to the Security Agreement, each Grantor executed, delivered, and recorded the Trademark Security Agreement, dated as of April 22, 2021 (“**Trademark Security Agreement**”) at the United States Patent and Trademark Office (“**USPTO**”) on May 5, 2021 at Reel 7280 Frame 0027 (“**Security Agreement**”); and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Collateral solely listed on Schedule A hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent and each Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

SECTION 2. Partial Termination and Release. Collateral Agent, without representation, warranty, or recourse, hereby:

- (a) terminates, cancels, discharges, and releases the security interest in, and the right to set off against, such Grantor’s right, title, and interest in and to all the Collateral listed on Schedule A attached hereto, granted pursuant to the Security Agreement. For the avoidance of doubt, this Partial Release does not terminate or release the Collateral Agent’s security interest in and lien on the Collateral not listed on Schedule A hereto; and
- (b) authorizes the recordation of this Partial Release with the USPTO at such Grantor’s expense.

SECTION 3. Choice of Law. This Partial Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, Collateral Agent has caused this Partial Release of Trademark Security Agreement to be duly executed as of the date first set forth above.
