**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 15, 2022 ("Release"), is made by The Bank of New York Mellon, FKA The Bank of New York ("Secured Party") in favor of The Solomon-Page Group Ltd., a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Security Agreement dated as of October 30, 2000 ("Security Agreement") by and among the Grantor, Secured Party, and others party thereto, Grantor granted to the Secured Party a security interest in and mortgage on, all Trademarks, and all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom, including the trademark registrations and trademark applications listed on Schedule 1 attached hereto (collectively, the "Trademark Collateral"); and

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on November 13, 2000 at Reel 2193 Frame 0341.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement.

SECTION 2. Termination and Release. Secured Party hereby:

(a) terminates, cancels, forever discharges, and releases the security interest in and mortgage on, all Trademark Collateral, including the trademark registrations and trademark applications listed on Schedule 1 attached hereto;

(b) represents and warrants that it has full authority to execute and deliver this Release; and

(c) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Further Assurances. Secured Party, at Grantor's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Secured Party will, at Grantor's expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Secured Party has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.

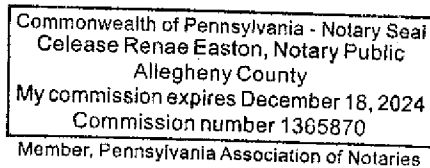
