INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (this “Assignment”) is made and entered into effective as of December 8, 2022 (the “Effective Date”) by Le Holding Angelcare Inc., a corporation incorporated under the laws of Canada (“Le Holding”), Angelcare USA, LLC, a Delaware limited liability company (“Angelcare USA”), Angelcare Canada Inc., a corporation incorporated under the laws of Canada (“Angelcare Canada”), Angelcare Feeding Canada Inc., a corporation incorporated under the laws of Canada (“Feeding Canada”) and Angelcare Feeding USA, LLC, a Delaware limited liability company (“Feeding USA” and together with Le Holding, Angelcare USA, Angelcare Canada, and Feeding Canada, collectively, the “Assignors” and each, an “Assignor”), in favor of JMBH Holdings, LLC, a Delaware limited liability company (“Assignee”).

RECITALS:

A. Pursuant to the terms of an Asset Purchase Agreement dated as of February 23, 2022, as amended by that certain First Amendment to Asset Purchase Agreement and Memorandum of Agreement dated December 8, 2022 (collectively, the “Purchase Agreement”), Assignee is acquiring from Assignors certain Purchased Assets of Assignors.

B. Capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Purchase Agreement.

C. In connection with and in furtherance of the Phase II Closing (as contemplated under the Purchase Agreement), Assignor wishes to transfer, assign, and convey to Assignee all of Assignor’s right, title and interest in and to the Phase II Transferred Intellectual Property, including without limitation the Intellectual Property Rights of Assignors described on the attached **Exhibit A** and the attached **Exhibit B**, subject to the terms and conditions of this Assignment and the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual representations, warranties, conditions and covenants contained herein and in the Purchase Agreement, the Assignors hereby agree as follows:

1. Assignment of the Assigned IP. Each Assignor hereby irrevocably and perpetually assigns, conveys and transfers to Assignee all of such Assignor’s right, title and interest in and to all Phase II Transferred Intellectual Property in the Field of Feeding, including without limitation the Intellectual Property Rights of Assignors in the Field of Feeding described on the attached **Exhibit A** and the attached **Exhibit B**, together with: (a) the goodwill of the business associated therewith and which is symbolized thereby; (b) all rights to sue for infringement of any such Phase II Transferred Intellectual Property, whether arising prior to or subsequent to the Effective Date; (c) all royalties, fees, income, payments and other proceeds now or hereafter due or payable in respect of any period as of and from the Effective Date with respect to any and all of the foregoing; (d) all rights of any kind whatsoever of such Assignor accruing as of and from the Effective Date under any of the foregoing provided by applicable law of any jurisdiction, by international treaties

and conventions and otherwise throughout the world; and (e) any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada, or in any other jurisdiction, the same to be held and enjoyed by the Assignee, its successors and assigns from and after the Effective Date as fully and entirely as the same would have been held and enjoyed by each such Assignor had this Assignment not been made.

2. Recordation; Further Assurances. Each Assignor hereby authorizes any governmental authorities including, without limitation, the United States Patent and Trademark Office and the Canadian Intellectual Property Office, to record and register this Assignment upon request by the Assignee. Each Assignor shall, at the request and cost of the Assignee, promptly sign, execute, make and do all such deeds, documents, acts and things as the Assignee or its duly authorized officers may reasonably require: (a) to apply for, obtain, register and vest in the name of the Assignee alone (unless the Assignee otherwise directs) patents, copyrights, trademarks or other analogous protection in any country throughout the world relating to the Phase II Transferred Intellectual Property, and when so obtained or vested to renew and restore the same; and (b) to assist in the defense of any judicial, opposition or other proceedings in respect of such applications and any judicial, opposition or other proceeding, petition or application for revocation of any such patent, copyright, trademark or other analogous protection. This includes, but is not limited to, cooperation in the registration of assignments of patents, trademarks, copyrights and any other rights which may in Assignee's reasonable opinion require registration for effective assignment of the Phase II Transferred Intellectual Property. With respect to any domain names included in the Phase II Transferred Intellectual Property, each Assignor shall, promptly after the Effective Date and for no additional consideration, take all steps as may be reasonably requested to effect such assignment and transfer in accordance with the domain name transfer procedures of the applicable registrar(s) for the assigned domain names, including, without limitation: (i) executing applicable domain name registrar transfer agreements or (ii) arranging for the domain names to be unlocked in preparation for their transfer to Assignee, and providing Assignee with the domain authorization code and any other authorization code that Assignee will need to initiate the transfer of the domain names to Assignee.

3. Waiver of Moral Rights. To the extent not assignable to Assignee pursuant to applicable law, Assignors hereby waive and agree never to assert any Moral Rights in or with respect to any or all of the Phase II Transferred Intellectual Property, together with any or all claims for damages and other remedies that may be asserted on the basis of Moral Rights. For the purposes of this Section 3, "Moral Rights" means any right to claim authorship to or to object to any distortion, mutilation, or other modification or other derogatory action in relation to a work, whether or not such action would be prejudicial to the author's reputation, and any similar right, regardless of whether or not such right is denominated or generally referred to as a "moral right."

4. Governing Law; Jurisdiction and Venue. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment and the transactions contemplated hereby and all disputes between the parties under or relating to this Assignment or the transactions contemplated hereby, whether in contract, tort or otherwise, will be governed by, and construed and enforced in accordance with, the laws of the State of New York, without regard to its rules of conflict of laws. Any action seeking to enforce any provision of this Assignment shall be instituted and adjudicated in the manner set forth in Section 9.10 of the Purchase

Agreement (or any successor provision) with Section 9.12 and 9.20 thereof (or any successor provisions) being hereby incorporated herein by reference.

5. Assignment. This Assignment and the covenants and agreements contained herein shall inure to the benefit of the Assignee and its successors, and shall bind the Assignors and their respective successors and permitted assigns.

6. Severability. Any term or provision of this Assignment that is invalid or unenforceable in any jurisdiction will, as to that jurisdiction, be ineffective to the extent of such invalidity or unenforceability without rendering invalid or unenforceable the remaining terms and provisions of this Assignment or affecting the validity or enforceability of any of the terms or provisions of this Assignment in any other jurisdiction. If any provision of this Assignment is so broad as to be unenforceable, the provision will be interpreted to be only so broad as is enforceable.

7. Counterparts. This Assignment may be executed in counterparts, including by PDF or other facsimile, each of which will be deemed an original but both of which will constitute but one instrument.

8. Purchase Agreement. Nothing set forth in this Assignment shall supersede or replace any of the representations or warranties set forth in, or any of the other provisions of, the Purchase Agreement. The Assignors and (by acceptant of this Assignment) the Assignee hereby acknowledge and agree that the representations, warranties, covenants, indemnities, limitations and other terms contained in the Purchase Agreement shall not be superseded, amended, modified, supplemented, limited or altered in any manner hereby but shall remain in full force and effect to the fullest extent provided therein. This Assignment is subject to and shall be governed by the terms and conditions of, the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.
