## ASSET AND GOODWILL PURCHASE AGREEMENT

This Asset and Goodwill Purchase Agreement is effective as of June 9, 2021, and is between East West Wisconsin, LLC, a Georgia limited liability company ("**Seller**") and Galahad Entertainment, LLC, a Texas limited liability company ("**Purchaser**").

Seller manufactures virtual combat technology and equipment in the Laser Tag industry under the iCOMBAT division (the "**Business**").

Seller wishes to sell certain of its assets of the iCOMBAT division to Purchaser.

Purchaser wishes to purchase certain of the assets of the Business, and Seller desires to sell such assets to Purchaser, all on the terms and conditions enumerated in this agreement.

Purchaser and Seller hereby agree as follows:

**1.1 Acquired Assets.** Seller hereby sells to Purchaser the assets (the "**Acquired Assets**") set forth on Addendum A.

**1.2 Excluded Assets.** Notwithstanding the foregoing, Seller will retain Seller's right title and interest in all assets, including the Laser Module, other than the Acquired Assets (the "**Excluded Assets**").

**1.3 Goodwill.** Seller hereby sells to Purchaser the goodwill (the "**Goodwill**") to the extent related to the business of Seller (the "Business"). As used herein, the "Goodwill" includes (i) all contacts, (ii) all referral lists, addresses, and other material information relating to clients, (iii) all lists of prospective clients, addresses, and other material information relating to prospective clients with whom Seller has developed a relationship and (iv) operating systems, training manuals or programs, marketing materials,

and any other information relating to the operation of the Business within the current possession of Seller, in each case, exclusively related to the Business.

**1.4 Purchase Price.**

(a) As an aggregate purchase price for the Acquired Assets (the” **Asset Purchase Price**”), Purchaser shall deliver, upon closing, certified funds in the amount of \$550,000. Purchaser shall also deliver, upon closing, to Seller a Secured Promissory Note in the amount of \$600,000, which shall be payable as follows:

- (i) \$180,000 six months from the date of closing; and
- (ii) \$420,000 eighteen months from the date of closing.

The sum of which shall equal the agreed upon total purchase price of \$1,150,000.

**1.5 Condition of the Acquired Assets.** EXCEPT AS SPECIFICALLY SET FORTH IN THIS AGREEMENT, EACH ASSET IS SOLD IN AN “AS IS,” “WHERE IS” CONDITION AND “WITH ALL FAULTS.” THE WARRANTIES SET FORTH IN THIS AGREEMENT ARE EXCLUSIVE AND IN SUBSTITUTION FOR, AND BUYER RELEASES AND RENOUNCES, ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, OF ANY KIND, WHICH IT MAY HAVE AGAINST THE SELLER ARISING BY LAW OR OTHERWISE, WITH RESPECT TO ANY DEFECT IN ANY ASSET OR ANY COMPONENT OR OTHER ITEM DELIVERED PURSUANT TO THIS AGREEMENT, WHETHER OR NOT DISCOVERABLE BY SELLER OR BUYER OR ANY WHOLLY OWNED SUBSIDIARY OF BUYER. THE PARTIES SPECIFICALLY STATE, ACKNOWLEDGE AND AGREE THAT AS RESPECTS THE CONDITION OF EACH ASSET, THERE IS: (A) NO WARRANTY AS TO THE PRODUCTIVENESS, SUITABILITY, USE, CAPACITY OR CONDITION OF ANY ASSET, VALUE, DESIGN, QUALITY, DURABILITY, COMPLIANCE WITH SPECIFICATIONS, MANUFACTURE, OPERATIONS OR CONDITION OF ANY ASSET, OR ANY COMPONENT OR OTHER ITEM DELIVERED PURSUANT TO THIS AGREEMENT, OR THE ABSENCE OF LATENT OR OTHER DEFECTS, WHETHER OR NOT DISCOVERABLE, WITH RESPECT THERETO; (B) NO EXPRESS OR IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR USE OR FOR A PARTICULAR PURPOSE; (C) NO REPRESENTATION OR EXPRESS OR IMPLIED WARRANTY OF FREEDOM FROM ANY CLAIM BY WAY OF INFRINGEMENT OF ANY PATENT, COPYRIGHT, TRADEMARK, TRADE SECRET OR THE LIKE; (D) NO EXPRESS OR IMPLIED WARRANTY ARISING FROM COURSE OF PERFORMANCE, COURSE OF DEALING OR USAGE OF TRADE; (E) NO OBLIGATION, LIABILITY, RIGHT, CLAIM OR REMEDY IN CONTRACT OR TORT, WHETHER OR NOT ARISING FROM THE ACTUAL OR IMPUTED

NEGLIGENCE OF EITHER PARTY OR ITS ASSIGNS; AND (F) NO OBLIGATION, LIABILITY, RIGHT, CLAIM OR REMEDY FOR LOSS OF OR DAMAGE TO ANY TANGIBLE OR INTANGIBLE THING, FOR LOSS OF USE, REVENUE, PROFIT OR TAX BENEFIT, OR FOR ANY OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND. IN NO EVENT SHALL SELLER BE LIABLE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, HOWEVER ARISING.

**2.1 Assumed Liabilities.** Purchaser does not assume the debts, obligations, and liabilities of Seller except as set forth in Addendum B.

**3.1 Allocation of Purchase Price.**

(a) An allocation of the purchase price is included in Addendum H.

(b) Seller and Purchaser will, to the extent permitted by applicable law, adopt and use the amounts allocated to each asset or class of assets as set forth above for purposes of all federal, state, and other tax returns or reports of any nature filed by it, and neither Seller nor Purchaser will voluntarily take any position inconsistent therewith on examination of any such tax returns or reports, in any claim for refund, in any litigation, or otherwise with respect to such tax returns or reports unless otherwise required by applicable law.

**3.3 Further Assurances.** At the Closing and from time to time after the Closing, at the request of Purchaser and without further consideration, Seller shall promptly execute and deliver to Purchaser such certificates and other instruments of sale, conveyance, assignment, and transfer, and take such other action as may reasonably be requested by Purchaser to more effectively to sell, convey, assign, and transfer to and vest in Purchaser or to put Purchaser in possession of the Acquired Assets in accordance with the terms of this agreement.

**4. Representations of Seller.** Except as otherwise set forth in any Schedule attached hereto, Seller represent to Purchaser as follows:

**4.1 Organization.** Seller is a limited liability company duly organized, validly existing, and in good standing under the laws of the State of Georgia. Seller has the requisite limited liability company power and authority to own the Acquired Assets and to carry on the Business as presently conducted. Seller is qualified to do business in Georgia.

**4.2 Authority.** Seller has the limited liability company power and authority to enter into this agreement and to consummate the transactions contemplated hereby. The execution and delivery of this agreement by Seller and the consummation by Seller of the transactions contemplated hereby have been duly authorized by all requisite limited liability company action on the part of Seller and no other action is necessary to authorize this agreement or to consummate the transactions contemplated hereby. This Agreement has been duly executed and delivered by Seller and constitutes the valid, binding, and enforceable obligation of Seller, subject only to bankruptcy, reorganization, insolvency, moratorium, fraudulent conveyance, and other laws affecting creditors' rights generally from time to time in effect and to general equitable principles (whether considered in a case at law or in equity).

**4.3 No Violations.** The execution and delivery of this agreement by Seller do not, and the consummation by Seller of the transactions contemplated hereby will not, conflict with, or result in any violation of or default (with or without notice or lapse of time, or both) under, or give rise to a right of termination under, or accelerate the performance required by, or result in the creation of any material lien, security interest, or other encumbrance, other than the Permitted Encumbrances (as hereinafter defined) (an "Encumbrance") upon any of the Acquired Assets under any provision of:

(a) any law, statute, regulation, or judicial or administrative decision applicable to Seller, the Business, or the Acquired Assets,

(b) the certificate of formation or limited liability company agreement of Seller,

(c) any mortgage, note, deed of trust, license, governmental permit, lease, contract, or agreement or other instrument or obligation to which Seller is a party or by which the Acquired Assets are or may be bound,

(d) any judgment, order, writ, injunction, or decree of any court, governmental body, administrative agency, or arbitrator applicable to Seller, the Business, or the Acquired Assets, other than conflicts, violations, defaults, rights of termination, or Encumbrances that, either individually or in the aggregate, are not reasonably expected to have a material adverse effect. Except as disclosed on Schedule 4.3, no consent, approval, or authorization of, or registration, declaration, or filing with, any governmental authority, and no consent of any person under any contract to which Seller is a party, is required to be obtained or made by Seller in connection with the execution and delivery of this agreement by Seller or the consummation by Seller of the transactions contemplated hereby, other than consents that if not obtained will not have a material adverse effect, or

(e) Any third party covenant not to compete agreements or commitments made by Seller to any party other than the Purchaser, including, any prior covenant not to compete agreements to which Seller are a party to, involving the sale of assets, Goodwill, or any non-compete provisions with respect to the same.

For purposes of this agreement, “Permitted Encumbrances” means (1) liens for taxes not yet due and payable or delinquent, (2) minor imperfections of title, easements, restrictions and encumbrances of record, (3) liens in respect of pledges or deposits under



workman's' compensation laws or similar legislation; (4) carrier's, warehouseman's mechanics, laborers' and materialmen's and similar liens, if the obligations secured by such liens are not then delinquent or are being contested in good faith by appropriate proceedings which, in the case of all of the foregoing (1)-(4), could not be reasonably expected to, individually or in the aggregate, materially interfere with the present use of or materially impair the value of the Business or the Acquired Assets or otherwise have a material adverse effect.

**5. Representations of Purchaser.** Purchaser represents to Seller:

**5.1 Organization.** Purchaser is a Texas resident.

**5.2 Authority.** Purchaser has the power and authority to enter into this agreement and to consummate the transactions contemplated hereby. This agreement has been duly executed and delivered by Purchaser and (assuming due authorization, execution, and delivery hereof by Seller) constitutes the valid, binding, and enforceable obligation of Purchaser, subject to applicable bankruptcy, reorganization, insolvency, moratorium, fraudulent conveyance, and other laws affecting creditors' rights generally from time to time in effect and to general equitable principles (whether considered in a proceeding at law or in equity).

**5.3 No Violations.** The execution, delivery and performance by Purchaser of this agreement and the other agreements contemplated hereby to which it is a party, and the consummation of the transactions contemplated hereby and thereby, do not and will not: (a) conflict with or result in a violation or breach of, or default under, any provision of the certificate of incorporation, by-laws or other organizational documents of Purchaser; (b) conflict with or result in a violation or breach of any provision of any law or

governmental order applicable to Purchaser; or (c) require the consent, notice or other action by any third party under any contract to which Purchaser is a party. No consent, approval, permit, governmental order, declaration or filing with, or notice to, any governmental authority is required by or with respect to Purchaser in connection with the execution and delivery of this agreement and the other agreements contemplated hereby and the consummation of the transactions contemplated hereby and thereby.

**5.4 No Brokers.** No broker, finder or investment banker is entitled to any brokerage, finder's or other fee or commission in connection with the transactions contemplated by this agreement or the other agreements contemplated hereby based upon arrangements made by or on behalf of Purchaser.

**6. Certain Covenants and Agreements of Seller and Purchaser.** The covenants and agreements that are to be observed or performed at any time after the Closing shall survive the Closing and be enforceable in accordance with their respective terms.

**6.1 Non-Compete.** Other than products and services provided to XTac Technologies, LLC by the Seller (which are the lasertag product families either sold direct to businesses or to individual consumers consisting of the components as listed on Addendum C), Seller hereby covenants and agrees that, for a period commencing on the Closing Date and ending five (5) years following the date of Closing, Seller shall not, and shall cause all of its Subsidiaries and Affiliates, not to, Compete, directly or indirectly, with the Purchaser by engaging, in any capacity, in the sales, marketing, promotion, manufacture (with the exception of Section 8.5) or distribution of any of the products reflected under Addendum D. For purposes of this provision, "Compete" means (i) to, directly or indirectly, conduct, facilitate, participate or engage in, or bid for or otherwise

pursue a business, on a global geographic basis, whether as a principal, sole proprietor, partner, stockholder, or agent of, or consultant to or manager for, any Person, or (ii) to, directly or indirectly, have any ownership interest in any Person or business which conducts, facilitates, participates or engages in, or bids for or otherwise pursues a business, whether as a principal, sole proprietor, partner, stockholder, or agent of, or consultant to or manager for, any such Person, in each case except as a passive investor with a non-controlling interest in such Person.

**6.2 Seller's Provision of Manufacturing Services.** Seller shall manufacture the products which are listed under Addendum D exclusively for the benefit of Purchaser for a period of one (1) year following the date of closing. Seller shall procure components, parts, and raw materials (collectively "Components") and manufacture, assemble, test, inspect, and configure these parts and Components into finished goods ("Products") in accordance with the specifications used in the Business immediately prior to Closing. All Products sold to Purchaser by Seller shall be under warranty for one year from Seller's shipment of the Products in the form of the Seller's standard product warranty as set forth on Addendum E. Seller shall provide these Products to Purchaser at the "Total Cost" as indicated for each Product under Addendum D. Seller may amend the Total Cost (up or down as the case may be) if the price of materials procured by the Seller varies from their current level, provided, however Seller shall give Purchaser advance notice of any price increase due to such materials. Seller may not amend the price of the products for any cost component other than the price of materials. Seller shall provide Purchaser with a breakdown of the Total Cost, as indicated in Addendum D, upon request. During the one

(1) year applicable to this Section 6.2, Seller may not increase the amount of Labor charge, SG&A charge, Mark-up or any other cost without obtaining Purchaser's approval.

Following the expiration of the initial one (1) year term in connection with Seller's manufacturing service, the parties may mutually agree to extend the agreement, or the Purchaser may elect to terminate the manufacturing provision of this agreement, at which point Purchaser would be entitled to seek manufacturing services from a third party. Should Purchaser elect to procure manufacturing services from any party other than Seller, Seller shall immediately cease the manufacture of the Products listed in Addendum D, and Seller shall not be entitled to any compensation or damages in connection with Purchaser's election to terminate Seller's Manufacturing agreement.

**6.3 Laser Module.** Seller shall retain ownership of the laser module technology owned by the Seller as of the date hereof related such technology assigned accession number 1620075-000 by the Department of Health & Human Services of the United States Food and Drug Administration (the "Laser Module"). Seller grants to Purchaser an exclusive, permanent, license to manufacture, market and sell the Laser module; provided, however, Seller may continue to license the Laser Module to XTac Technologies, LLC and manufacture for, and sell the Laser Module to, XTac Technologies, LLC. Seller shall make all the drawings, plans, schematics, suppliers and all other inputs necessary for the production of the Laser Module available to Purchaser. Seller shall not be entitled to any compensation in connection with Laser Module license agreement beyond the purchase price under Section 1.3 of this agreement.

**6.4 Existing Agreements.** Seller shall assign to Purchaser the agreements included under Addendum F and Seller shall use commercially reasonable efforts to obtain

any required consents of third parties associated with such assignment. Purchaser shall reasonably cooperate with Seller in obtaining such consents to assignment. Purchaser agrees to be bound by the terms of the agreements under Addendum F upon such assignment; provided, however, Purchaser shall not be liable for any claims or damages in connection with any acts by Seller prior to the date of Closing, and Purchaser shall not be liable for any claims by the counterparties to these agreements in connection to claims concerning the assignment of such contracts to Purchaser.

**7. Closing.**

**7.1 Closing Date.** The closing of the transactions provided for herein (the "Closing") will take place upon the execution of this Agreement, (the date of the Closing being the "Closing Date"). For all purposes of this agreement, the transactions consummated at the Closing shall be deemed to have been consummated as of the close of business on the Closing Date (the "Effective Date").

**7.2 Closing Deliverables.** At the Closing (or at such time set forth below):

- (a) Seller shall execute and deliver to Purchaser the General Assignment and Warranty Bill of Sale; and
- (b) Purchaser shall execute and deliver to Seller, as the case may be, the Promissory Notes.

**8. Survival of Representations and Warranties; Indemnification.**

**8.1 Survival.** The respective representations of Seller and of Purchaser hereunder shall survive for a period of two years from the Effective Date, if a party claiming any breach of any such representations and warranties shall give written notice to the other party within such two-year period. Any covenants or agreements herein that by

their terms apply to periods after the Closing shall survive the closing of the transactions contemplated hereby.

**8.2 Indemnification of Purchaser.** Subject to the terms of Section 1.5 and Section 8.5 below, Seller shall defend, indemnify, and hold harmless Purchaser and his successors and assigns (individually, a "Purchaser Indemnitee" and collectively, the "Purchaser Indemnitees") against and in respect of:

- (a) any and all losses, damages, deficiencies, liabilities, or expenses (including reasonable attorneys' fees and expenses, whether incurred in arbitration, at trial or on appeal) ("Damages") suffered or incurred by any such Purchaser Indemnitee that are caused by, or result or arise from, any failure by Seller to perform or otherwise fulfill or comply with any undertaking or other agreement or obligation to be performed, fulfilled, or complied with by Seller hereunder; and
- (b) all Damages suffered or incurred by any Purchaser Indemnitee that are caused by, or resulting or arising from, any breach of any representation or warranty of Seller contained in this agreement.

**8.3 Indemnification of Seller.** Subject to the terms of Section 8.5 below, Purchaser shall defend, indemnify, and hold harmless Seller and its successors and assigns (individually, a "Seller Indemnitee", and collectively, the "Seller Indemnitees"), against and in respect of:

- (a) any and all Damages suffered or incurred by any Seller Indemnitee that are caused by, or result or arise from, any failure by Purchaser to perform or otherwise fulfill or comply with any undertaking or other agreement or obligation to be performed, fulfilled, or complied with by Purchaser; and

(b) all Damages suffered or incurred by any Seller Indemnitee that are caused by, or resulting or arising from, any breach of any representation or warranty of Purchaser contained in this agreement.

**8.4 Notice and Opportunity to Defend.** If any action, suit, proceeding, claim, liability, demand, or assessment is asserted against any Purchaser Indemnitee or any Seller Indemnitee (the "Indemnitees") in respect of which such Indemnitees propose to demand indemnification, such Indemnitees shall promptly notify the party obligated to provide indemnification pursuant to Section 8.2 or 8.3 (the "Indemnifying Party"), stating in the notice with particularity the nature and basis of the claim with respect to which indemnification is being demanded. Subject to rights of or duties to any insurer or other third person having liability therefor, the Indemnifying Party shall have the right to assume the control of the defense, compromise, or settlement of any such action, suit, proceeding, claim, liability, demand, or assessment, including, at its own expense, employment of counsel if the Indemnifying Party shall have exercised its right to assume such control, the Indemnitees (1) may, in their sole discretion and at their own expense, employ separate counsel to represent them in any such matter, and in such event counsel selected by the Indemnifying Party shall be required to cooperate with such counsel of the Indemnitees in such defense, compromise, or settlement for the purpose of informing and sharing information with such Indemnitees and (2) will, at their own expense, make available to the Indemnifying Party those employees of the Indemnitees (including, in the case of Purchaser, the Business) whose assistance, testimony, or presence is desirable to assist the Indemnifying Party in evaluating and in defending any such action, suit, proceeding, claim, liability, demand, or assessment, and any such access shall be conducted in such a manner

as not to interfere unreasonably with the operations of the businesses of the Indemnitees (including, in the case of Purchaser, the Business). The Indemnifying Party shall not compromise or settle any such action, suit, proceeding, claim, liability, or assessment without the consent of the Indemnitees, which consent shall not be unreasonably withheld, conditioned, or delayed.

**8.5 Certain Limitations Applicable to Breach of Representations or Warranties.** No Damages shall be asserted by a Seller Indemnitee or a Purchaser Indemnitee with respect to any claim that is covered by insurance or with respect to facts that are disclosed in this agreement or any schedule or exhibit hereto. Notwithstanding anything to the contrary, (1) the Seller shall not be liable hereunder to Purchaser as a result of any misrepresentation or breach of any representation, warranty, covenant, or agreement contained in this agreement, unless and until the Damages incurred by the Purchaser as a result of such breach under this agreement shall exceed, in the aggregate, \$11,500 (the “**Basket Threshold**”), and once such Damages incurred by the Purchaser exceeds \$11,500, the Purchaser shall be entitled to indemnification for Damages in the amount of the Basket Threshold, plus Damages in excess of \$11,500. The aggregate amount of all Damages for which Seller shall be liable pursuant to Section 8.2 shall not exceed \$200,000. After the Closing, the rights set forth in Section 8.2 shall be the Purchaser’s sole and exclusive remedy against the Seller for any claim or dispute relating in any way to the subject matter of this agreement, except to the extent specifically provided otherwise in any other agreement or instrument contemplated by this agreement.



**9. Miscellaneous.**

**9.1 Expenses.** Each of the parties hereto shall pay the fees and expenses of its respective counsel, accountants, and other experts and shall pay all other expenses incurred by it in connection with the negotiation, preparation, and execution of this agreement and the consummation of the transactions contemplated hereby. Purchaser shall bear all costs of any documentary, stamp, sales, excise, transfer, or other tax or recording or filing fees and charges payable in respect of the sale of the Acquired Assets.

**9.2 Governing Law.** The laws of the State of Texas shall govern all matters arising out of this agreement without reference to choice of law principles, including all matters of construction, validity, and performance.

**9.3 Judicial Proceedings; Waiver of Trial by Jury.** Any judicial proceeding brought against any party to this agreement in accordance with this agreement with respect to any claim related to this agreement shall be brought in any court of competent jurisdiction in the County of [\_\_\_\_], State of Texas, and, by the execution and delivery of this agreement, each party to this agreement accepts, generally and unconditionally, the exclusive jurisdiction of such courts and any related appellate court and irrevocably agrees to be bound by any judgment rendered thereby in connection with any claim related to this agreement and brought in such a court in accordance with this agreement and irrevocably waives any objection it may now or hereafter have as to the venue of any such proceeding brought in such a court or that such a court is an inconvenient forum. Each party to this agreement hereby waives trial by jury in any judicial proceeding to which it is a party involving any claim arising out of or related to this agreement.
