THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of January 10, 2023 (“Effective Date”) by Fifth Third Bank, National Association, an Ohio banking corporation, with its mailing address at Fifth Third Center, MD 10947, Cincinnati, OH 45263 as Administrative Agent, on behalf of the Secured Creditors, in favor of Life Line Screening of America Ltd., an Ohio limited liability company, with its principal place of business and mailing address at 5400 Transportation Boulevard, Garfield Heights, Ohio 44125 (“Borrower”).

WHEREAS, the Borrower and the Secured Creditors are party to that certain Security Agreement dated July 31, 2008, and capitalized terms not defined herein have the meanings set forth in the Security Agreement;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Collateral Agreement by and between Borrower and Administrative Agent dated July 31, 2008 (the “Trademark Security Agreement”), Borrower granted to Administrative Agent a continuing security interest in and to:

- (i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and
- (ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages (collectively, (i) and (ii), the “Trademark Collateral”).

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on August 1, 2008, at Reel 3827, Frame 0225;

WHEREAS, Borrower has paid all of its outstanding indebtedness owed the Secured Creditors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release and Termination. Administrative Agent, on behalf of itself and the Secured Creditors, hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.
2. Authorization. Agent hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office, as well as the intellectual property offices of any other jurisdictions where any Trademark Collateral is registered, to release the above-referenced security interests.

3. Further Assurances. Agent shall take all further actions, and provide to Borrower, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Borrower to more fully and effectively effectuate the purposes of this Release.


