The undersigned corporation, Graco High Pressure Equipment Inc., a Minnesota corporation, hereby certifies as follows:

1. The names and states of incorporation or organization of each of the constituent business entities of the merger are as follows:

(a) Graco High Pressure Equipment Inc., which is incorporated under the laws of the State of Minnesota ("Graco HIP");

(b) High Pressure Equipment Holdings LLC, which is organized under the laws of the State of Delaware ("Holding Company"); and

(c) High Pressure Equipment Company LLC, which is organized under the laws of the State of Delaware ("Operating Company," and together with Holding Company, the "Subsidiaries").

2. An Agreement and Plan of Merger dated as of January 21, 2015 (the "Merger Agreement") between Graco HIP, Holding Company, Operating Company, High Pressure Equipment (Wasserstein HIP Corp.), a Delaware corporation, and Audax HIP, Inc., a Delaware corporation, has been approved, adopted, certified, executed and acknowledged by each of the constituent business entities in accordance with Section 18-209 of the Delaware Limited Liability Company Act.

3. The name of the surviving corporation shall be Graco High Pressure Equipment Inc.

4. The executed Merger Agreement is on file at the following office of the surviving corporation: 88 - 11th Avenue Northeast, Minneapolis, Minnesota 55413.

5. A copy of the Merger Agreement will be furnished by the surviving corporation on request and without cost to any member or shareholder of any constituent entity.


