**ASSIGNMENT OF
GRANT OF A SECURITY INTEREST – TRADEMARKS**

THIS ASSIGNMENT OF GRANT OF A SECURITY INTEREST – TRADEMARKS (this “Assignment”) is made as of January 12, 2023, by Modern Bank, N.A. in its capacity as former Administrative Agent (the “Former Agent”), in favor of McLarty Capital Partners SBIC II, L.P., in its capacity as successor Agent (the “Agent”) under the Loan, Guaranty and Security Agreement dated July 31, 2020 (the “Credit Agreement”) by and among Envase Holdings, LLC, a Delaware limited liability company (“Holdings”), the subsidiaries of Holdings party thereto, including SecurSpace Holdings, LLC, a Delaware limited liability company (the “Grantor”) and the Agent.

WHEREAS, the Grantor entered into that certain Notice of Grant of Security Interest in Trademarks, dated as of November 22, 2021, in favor of Former Agent, notice of which was recorded with the United States Patent and Trademark Office on November 22, 2021 at reel/frame 7557/0058 (the “Trademark Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement;

WHEREAS, the Grantor granted to Former Agent, under the terms of the Trademark Security Agreement, a security interest in favor of Former Agent, in and to all of its right, title and interest in and to the Trademarks, including without limitation the trademarks listed in Schedule A hereto;


WHEREAS, under the terms of the Credit Agreement, the Former Agent has resigned and is replaced by the Agent, pursuant to a Resignation of Agent and Successor Agent Agreement dated June 1, 2022 (the “Agent Agreement”), pursuant to which the Former Agent agreed to assign all the security interests under the Credit Agreement to the Agent.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Former Agent hereby assigns its security interest in the Trademarks to the Agent, including, without limitation, the trademarks listed in Schedule A hereto and made a part hereof. If and to the extent that the Former Agent has acquired any right, title or interest in and to the Trademarks, the Former Agent hereby assigns, transfers and conveys to the Agent any and all such right, title and interest in such Trademarks. This Assignment shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
