CERTIFICATE OF MERGER

Pursuant to Section 18-209 of the Delaware Limited Liability Company Act, as amended (the "Delaware Limited Liability Company Act"), the undersigned entities have executed the following Certificate of Merger:

FIRST: The name, jurisdiction of organization, and type of entity of each of the constituent entities involved in the merger are as follows:

SECOND: An Agreement and Plan of Merger (the "Agreement") dated as of December 5, 2022, setting forth the terms and conditions of the merger of Trader TN Holdings, LLC with and into Trader Interactive, LLC (the "Merger"), has been approved and executed by each of the constituent entities involved in the merger in accordance with the Delaware Limited Liability Company Act.

THIRD: The name of the surviving entity is Trader Interactive, LLC, a Delaware limited liability company (the "Surviving Company").

FOURTH: The Certificate of Formation of the Surviving Company in effect immediately prior to the Merger shall remain in effect as the Certificate of Formation of the Surviving Company following consummation of the Merger.

FIFTH: The Merger shall be effective on December 31, 2022, at 11:59 PM local time in the State of Delaware.

SIXTH: An executed copy of the Agreement is on file at 4525 Main Street, Suite 1101, Virginia Beach, VA 23462, the principal place of business of the Surviving Company.

SEVENTH: A copy of the Agreement will be furnished by the Surviving Company, on request and without cost, to any member of or any other person holding an interest in either of the constituent entities involved in the Merger.

EIGHTH: The Surviving Company is a limited liability company organized under the laws of the State of Delaware.
