RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF NOTICE OF SECURITY INTEREST IN TRADEMARKS, dated as of January 12, 2023 (this “Release”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as Agent (the “Releasor”), in favor of Marble Point Credit Management LLC (“MPCM”).

WHEREAS, reference is made to that certain Guaranty and Security Agreement, dated as of December 20, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), by and among MPCM, the other grantors from time to time party thereto and the Releasor. Capitalized terms used herein but not defined herein shall have the meanings ascribed to them in the Guaranty and Security Agreement;

WHEREAS, pursuant to and as set forth in Notice of Grant of Security Interest in Trademarks, dated as of December 20, 2019 (the “Trademark Security Agreement” and collectively with the Guaranty and Security Agreement, the “Security Agreements”), made by MPCM in favor of the Releasor, MPCM granted to the Releasor a security interest in and continuing lien on (referred to in this Release as the “Security Interest”) all of its right, title and interest in, to or under the trademarks and trademark applications listed on Schedule I hereto (the “Released Trademarks”), and all related goodwill therein (collectively, the “Released Trademarks Collateral”);

WHEREAS, the Releasor recorded its security interest in the Released Trademarks Collateral with the United States Patent and Trademark Office (the “USPTO”) on August 14, 2020, at Reel/Frame No. 7024/0425;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Releasor hereby (i) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges its Security Interest and all of its right, title and interest in or to the Released Trademark Collateral pledged and granted pursuant to the Security Agreements and (ii) terminates the Security Agreements with respect to the Released Trademark Collateral and reassigns to MPCM any and all right, title and interest that the Releasor may have in or to any of the Released Trademark Collateral.

2. Authorization to Record. The Releasor authorizes and requests that the USPTO and any applicable government officer record this Release with the USPTO.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.
