CERTIFICATE OF MERGER**

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned does hereby certify to the following relating to the merger (the “***Merger***”) of Kroy Building Products, Inc., a Delaware corporation and Napco, Inc., a Delaware corporation, with and into Mastic Home Exteriors, Inc., an Ohio corporation (“***Mastic***”):

FIRST: The name and state of incorporation of each of the constituent corporations (the “***Constituent Corporations***”) to the Merger are as follows:

SECOND: The Agreement of Merger, dated as of December 13, 2022 (the “***Merger Agreement***”), has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations.

THIRD: Mastic shall be the surviving corporation in the Merger and the name of the surviving corporation shall be “Mastic Home Exteriors, Inc.” (the “***Surviving Corporation***”).

FOURTH: The Certificate of Incorporation of the Surviving Corporation, as in effect immediately prior to the Merger, shall be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: The Merger shall be effective at 11:59:00 p.m., Eastern Standard Time on December 31, 2022.

SIXTH: The Merger Agreement is on file at 5020 Weston Parkway, Cary, North Carolina 27513, the place of business of the Surviving Corporation.

SEVENTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation on request, without cost, to any stockholder of the Constituent Corporations.

EIGHTH: The Surviving Corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of the Surviving Corporation arising from this merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section

262 of the Delaware General Corporation Law, and irrevocably appoints the Secretary of State of Delaware as its agent to accept services of process in any such suit or proceeding. The Secretary of State shall mail any such process to the Surviving Corporation at 5020 Weston Parkway, Cary, North Carolina 27513.
