Pursuant to Title 8, Sections 252 and 264 of the Delaware General Corporation Law and Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned does hereby certify to the following relating to the merger (the "**Merger**") of Reed's Metals, LLC, a Delaware limited liability company, Reed's Metals of Alabama, LLC, a Delaware limited liability company, Union Corrugating Company Holdings, Inc., a Delaware corporation, and UCC Intermediate Holdings, Inc., a Delaware corporation, with and into Union Corrugating Company, a North Carolina corporation:

**FIRST:** The name and state of formation of each of the constituent corporations (the "**Constituent Companies**") to the Merger are as follows:

**THIRD:** Union Corrugating Company shall be the surviving corporation in the Merger and the name of the surviving corporation shall be "Union Corrugating Company" (the "**Surviving Corporation**").

**FOURTH:** The Certificate of Incorporation of the Surviving Corporation, as in effect immediately prior to the Merger, shall be the Certificate of Incorporation of the Surviving Corporation.

**FIFTH:** The Merger shall be effective at 11:59:00 p.m., Eastern Standard Time on December 31, 2022 in the sequence set forth in the Merger Agreement.

**SIXTH:** The Merger Agreement is on file at 5020 Weston Parkway, Cary, NC 27513, the place of business of the Surviving Corporation.

**SEVENTH:** A copy of the Merger Agreement will be furnished by the Surviving Corporation on request, without cost, to any member or stockholder of the Constituent Companies.

**EIGHTH:** The Surviving Corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of the Surviving Corporation arising from this merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the Delaware General Corporation Law or for the enforcement of any obligation of any domestic limited liability company which is to merge, and irrevocably appoints the Secretary of State of Delaware as its agent to accept services of process in any such suit or proceeding. The Secretary of State shall mail any such process to the Surviving Corporation at 5020 Weston Parkway, Cary, NC 27513.
