**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of January 12, 2023, by **BMO HARRIS BANK N.A.**, a United States national association (in such capacity, together with its successors and assigns, “Agent”) in favor of **KEMPER SPORTS MANAGEMENT, LLC**, a Delaware limited liability company with an address at 500 Skokie Boulevard, Suite 444, Northbrook, Illinois 60062, **KEMPERLESNIK COMMUNICATIONS, LLC**, an Illinois limited liability company with an address at 500 Skokie Boulevard, Suite 444, Northbrook, Illinois 60062, **GLENVIEW GOLF COURSE, L.L.C.**, a Delaware limited liability company with an address at 500 Skokie Boulevard, Suite 444, Northbrook, Illinois 60062, **KEMPER SPORTS MARKETING, LLC**, an Illinois limited liability company with an address at 500 Skokie Boulevard, Suite 444, Northbrook, Illinois 60062 and **WHISKEY CREEK GOLF COURSE, L.L.C.**, a Delaware limited liability company with an address at 500 Skokie Boulevard, Suite 444, Northbrook, Illinois 60062 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, Grantors entered into a certain trademark security agreement dated May 4, 2022 (the “Trademark Security Agreement”) with Agent, notice of which was recorded on May 4, 2022 at the United States Patent and Trademark Office at Reel 7711, Frame 0863.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in all of each such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation the trademarks listed in Schedule A.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


