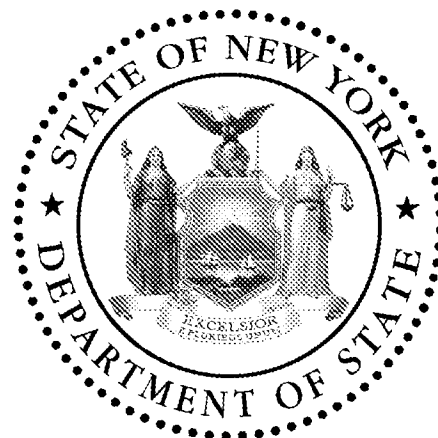

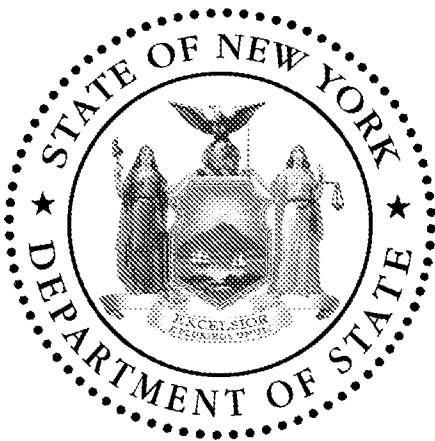

FIRST: The Board of Directors of the Corporation has adopted a plan of merger setting forth the terms and conditions of merging Second Language Testing, Inc., a corporation organized under the laws of the State of Maryland on April 5, 1994 and a 100% owned subsidiary of the Corporation ("SLTI"), with and into the Corporation.

SECOND: The laws of the State of Maryland permit a merger of the kind certified herein.

THIRD: SLTI has not filed an Application for Authority in the State of New York to transact business as a foreign corporation.

FOURTH: The name of the surviving corporation is Berlitz Languages, Inc.



SIXTH: The merger of SLTI into the Corporation has been authorized under the laws of the State of Maryland, the jurisdiction of incorporation of SLTI.

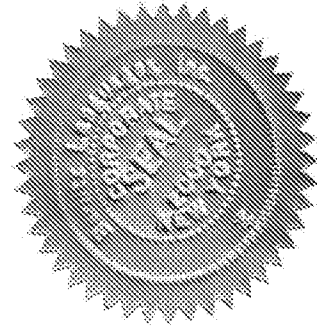
