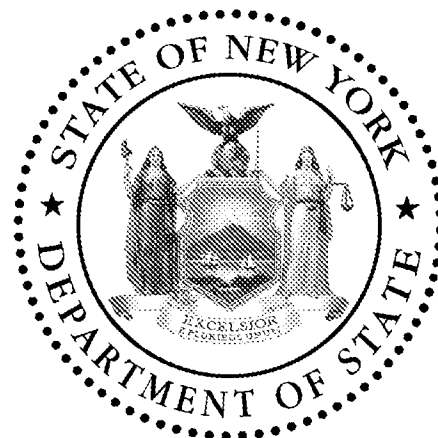

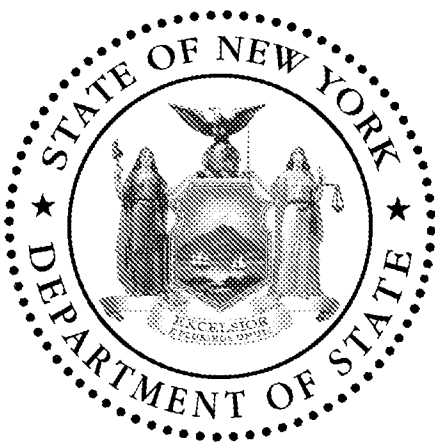

It is hereby certified by Berlitz Languages, Inc., a corporation organized under the laws of the State of New York on February 2, 2000 (the "Corporation"), as follows:

FIRST: The Board of Directors of the Corporation has adopted a plan of merger setting forth the terms and conditions of merging Training Management Corp. a corporation organized under the laws of the State of New Jersey on January 30, 1985 and a 100% owned subsidiary of the Corporation ("TMC"), with and into the Corporation.

SECOND: The laws of the State of New Jersey permit a merger of the kind certified herein.

THIRD: TMC has not filed an Application for Authority in the State of New York to transact business as a foreign corporation.

FOURTH: The name of the surviving corporation is Berlitz Languages, Inc.



SIXTH: The merger of TMC into the Corporation has been authorized under the laws of the State of New Jersey, the jurisdiction of incorporation of TMC.

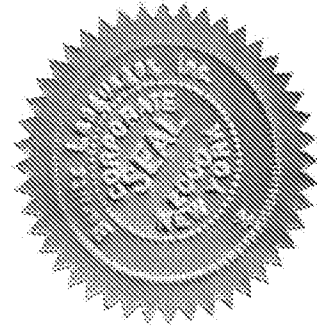
