**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

The Agent hereby authorizes the Company, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the trademarks contemplated hereby.
