
CONFIRMATION OF ASSIGNMENT



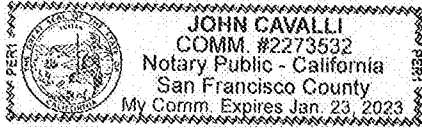
