RELEASE OF SECURITY INTEREST IN TRADEMARKS

FOR VALUE RECEIVED, the undersigned, REGIONS BANK (the "Secured Party"), hereby releases any and all liens and security interests granted and pledged to it by PULL-A-PART, LLC, a Georgia limited liability company (the "Grantor"), pursuant to that certain Security Agreement dated as of July 18, 2013 (the "Security Agreement") and the associated Notice of Grant of Security Interest in Trademarks dated as of July 18, 2013 (the "Trademark Security Agreement"), between Secured Party and the Grantor, WITHOUT ANY REPRESENTATION OR WARRANTY OF TITLE AND WITHOUT RECOURSE, including without limitation all liens on and security interest in, (i) the trademarks and trademark applications listed on Schedule I hereto, (ii) all renewals, reversions and extensions thereof, (iii) all income, royalties, proceeds, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (iv) the right to sue for past, present and future infringements thereof, and (v) all rights corresponding thereto throughout the world (collectively, the "Trademark Collateral"), as recorded on behalf of the Secured Party by the United States Patent and Trademark Office on July 18, 2013 as Document Number 900260991 at Reel 5073 Frame 0425.

To the extent the Secured Party retains any interest in any Trademark Collateral, the Secured Party hereby assigns, transfers and conveys to the Grantor all of the Secured Party's right, title and interest, now owned or hereinafter acquired pursuant to the Security Agreement and the Trademark Security Agreement and any documents, instruments or agreements related thereto. Such assignment, transfer and/or conveyance by the Secured Party is made WITHOUT ANY REPRESENTATION OR WARRANTY OF TITLE AND WITHOUT RECOURSE. The Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release of Security Interest in Trademarks; and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement or the Trademark Security Agreement.

The Secured Party shall, at the Grantor's sole cost and expense, take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this release. The Secured Party hereby authorizes the Grantor, or the Grantor's designee, to prepare and file any other documents as may be required to terminate or release the Secured Party's interest in any Trademark Collateral.
