**TERMINATION AND RELEASE OF SECURITY
INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 17, 2023 (“Release”), is made by **Wells Fargo Bank, National Association**, as agent (“Wells Fargo”) in favor of **Foodservices Brand Group, LLC (f/k/a/ COHG Acquisition, LLC)** (“FBG”) as assignee of **Franklin Financial Management, LLC**, a California Limited Liability Company (“Franklin”) and together with FBG, “Grantor”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement October 16, 2014, between Grantor and Wells Fargo (the “Security Agreement”), Grantor granted to Wells Fargo a continuing security interest in all right, title and interest of Grantor in and to all Trademarks (as defined in the Security Agreement), including the Trademarks identified on the attached Schedule A hereto;

WHEREAS, the security interest identified herein was recorded with the United States Patent and Trademark Office (“USPTO”) on October 16 2014, at Reel 005382 Frame 0120; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement referenced in the preamble and recitals hereto.

SECTION 2. Termination and Release. Wells Fargo, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

- (a) terminates, cancels, discharges and releases the continuing security interest, to the extent they exist in, Grantor’s right, title, and interest in and to the Trademarks, including those identified on Schedule A attached hereto, granted pursuant to the Security Agreement; and
- (b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
