TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (this “Termination and Release”) is made as of the January 18, 2023, by WOODFOREST NATIONAL BANK, as administrative agent (the “Agent”) to Vision Produce Acquisition, LLC, a Delaware limited liability company (formerly known as APB, Inc., a California corporation) (the “Grantor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Security Agreement (defined below) or the Trademark Security Agreement (defined below), as applicable.

W I T N E S S E T H

WHEREAS, pursuant to that certain Guarantee and Security Agreement, dated as of May 6, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Grantor, certain other grantors party thereto and the Agent, the Grantor entered into that certain Trademark Security Agreement, dated as of August 20, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) in favor of the Agent, which was recorded in the United States Patent and Trademark Office on August 31, 2021, at Trademark Reel 7403 Frame 0848, pursuant to which the Grantor granted a security interest to the Agent in the Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule I hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. the Agent hereby (i) terminates and cancels the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the security interest in and to the Trademark Collateral, including those Trademarks set forth on Schedule I, and re-assigns, grants and conveys to the Grantor, without any representation, warranty or recourse by the Agent, any and all of the Agent’s right, title, and interest in and to the Trademark Collateral, along with any goodwill in the Trademark Collateral that the Agent may have acquired.

2. the Agent hereby authorizes the Grantor and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral) to record this Termination and Release with the United States Patent and Trademark Office.


