**NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of January 12, 2023 is made by CITIBANK, N.A., a national banking association organized under the laws of the United States in its capacity as trustee (referred to herein as the "Trustee"), in favor of DCP Rights, LLC, a Delaware limited liability company (the "Company").

**WITNESSETH:**

WHEREAS, the Company and the Trustee entered into that certain Base Indenture, dated as of December 29, 2014, as amended and restated by that certain Amended and Restated Base Indenture, dated as of December 19, 2019 (and as the same may be further amended or modified from time to time, the "Indenture");

WHEREAS, in connection with the Indenture, the Company executed and delivered the Grant of Security Interest in Trademarks, dated as of December 29, 2014, in favor of the Trustee (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Company pledged and granted to the Trustee for the benefit of the other Secured Parties a lien on and continuing security interest in all of their intellectual property, including but not limited to the trademarks, service marks and trademark and service mark registrations and applications set forth on Schedule A attached hereto, together with the goodwill of the business symbolized thereby (the "Released Trademarks");

WHEREAS, the Trustee recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the "USPTO") on December 30, 2014, at Reel/Frame No. 5431/0874; and

WHEREAS, the Trustee has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Trustee agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Indenture, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Indenture).

SECTION 2. Release of Security Interest. The Trustee does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Company's right, title and interest in, to and under the Released Trademarks.

SECTION 3. Termination. The Trustee, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

SECTION 4. Further Assurances. The Trustee hereby authorizes the Company or the Company's authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Trustee in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Trustee further agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or their agents or designees) reasonably request (at the Company's sole cost and expense) in order to confirm this Release and the Company's right, title and interest in, to and under the Released Trademarks.

SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

SECTION 6. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
