**DECLARATION IN SUPPORT OF  
CORRECTION OF REGISTRATION  
TO CLARIFY OWNERSHIP**

Mitchell Schwartz, pursuant to 28 USC § 1746, declares as follows:

1. I am the Senior Vice President, Head of Litigation and Intellectual Property of MLB Advanced Media, Inc., general partner of MLB Advanced Media, L.P., agent for Boston Red Sox Baseball Club Limited Partnership, a Massachusetts limited partnership with offices at Fenway Park, 4 Jersey Street, Boston, Massachusetts 02215, and I am authorized to execute this Affidavit on behalf of Boston Red Sox Baseball Club Limited Partnership.

2. **Boston Red Sox Baseball Club Limited Partnership**, a Massachusetts limited partnership, is the true owner of U.S. Registration No. 1,014,874 (the "Registration") for the Socks and Baseball Design mark shown above. However, **Boston Red Sox Baseball Club, The** (omitting "Limited Partnership") was mistakenly stated as the name of the assignee in the assignment of Registration No. 1,014,874 recorded on April 12, 1985 at Reel/Frame 0413/0392. Accordingly, the registrant is incorrectly identified in all the records of the United States Patent and Trademark Office for the Registration as **Boston Red Sox Baseball Club, The** (omitting "Limited Partnership").

3. As of June 1, 1978, the date the registration was assigned, and March 17, 1982, the date the assignment document was executed, there was no official entity known as **Boston Red Sox**

**Baseball Club, *The*** and the official entity was known as at all times **Boston Red Sox Baseball Club Limited Partnership.**

4. The address for Boston Red Sox Baseball Club Limited Partnership has also changed.

5. It is respectfully requested that all records of the United States Patent and Trademark Office in connection with Reg.
